DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

RETREATED

JCI weakened and closed at 6,645 (-48 points or -0.72%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 83Bn today and rupiah slightly weakened to IDR 14,318/USD.

Banking stocks were mixed as BBRI (+0.72%), BBNI (+1.41%), and BMRI (+0.35%) advanced, while MEGA (-0.79%) and BBCA (-1.27%) retreated. Consumer names were mixed as KLBF (+0.59%) and SIDO (+1.07%) in green, while INDF (-0.38%), MYOR (-1.4%), and UNVR (-1.66%) corrected. Construction stocks were negative as ADHI (-6.74%), PTPP (-7%), WIKA (-6.64%), and WSKT (-6.35%) all declined. Mining names were mostly negative as TINS (-3.21%), ADRO (-0.44%), INCO (-2.31%), and ANTM (-4.87%) all retreated, except ITMG (+2.05%). Other movers were TOBA (+16.44%), BYAN (+5%), BBHI (-6.64%), and EMTK (-6.34%).

December trade surplus compressed to US\$1bn, from US\$3.5bn in Nov, significantly lower vs. consensus (US\$3.1bn). The compression follows a MoM drop in exports (-US\$0.5bn) and a MoM rise in imports (+US\$2.0bn). The decline in exports was largely contributed by bulk commodities such as coal (-US\$0.9bn) and gold (-US\$0.3bn). Meanwhile the MoM rise in imports was contributed by increases in e.g. machinery (+US\$0.4bn) and vaccines (+US\$0.3bn).

BOND MARKET

SLOW DAY


Bond market opened the week softer and bidders were on defensive mode with 10Y UST yield touched 1.78%. Overall market was relatively quiet with small trades on benchmark and non benchmark series. Several activity was seen from local and foreign as most players prepared for tomorrow auction. The appetite remained focus on front to 10Y area. By the end of day yield curve closed slightly higher by 1-2 bps. In the afternoon, government announced December Trade Balance data recorded at +USD 1.02 bio (vs consensus of +USD 3.129 bio).

Tomorrow, Indonesia Debt Management Office ("DMO") will hold its regular bond auction with IDR 25Tn target of issuance comprising of 3mo SPN, 12mo SPN, 5Y FR90, 10Y FR91, 15Y FR93, 20Y FR92 and 30Y FR89.


