DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

FLAT

JCI was flat and closed at 6,996 (-5 points or -0.07%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 806Bn today and rupiah was stabilized at IDR 14,347/USD.

Banking stocks were mixed as BMRI (+1.3%), BBRI (+0.22%), and BBNI (+0.62%) inched higher, while MEGA (-3.35%) and BBCA (-0.32%) weakened. Consumer names were mixed as HMSP (+0.55%), KLBF (+0.3%), and ICBP (+0.33%) in green, while INDF (-0.83%) and UNVR (-2.29%) closed lower. Mining stocks were mostly positive as INCO (+4.07%), ITMG (+2.56%), PTBA (+0.91%), and INDY (+0.44%) all closed higher, except ANTM (-1.96%). Infra names were mixed as PGAS (+3.26%) and JSMR (+2.69%) up, while TOWR and TBIG unchanged. Other movers were BIPI (+25.93%), BCAP (+9.46%), ARTO (-3.81%), and FREN (-3.8%).

Indonesia Ministry of Finance confirmed that the value-added tax (VAT) increase would take effect from 1 Apr. The increase in the VAT rate is from 10% to 11%. The Directorate General of Taxes (DGT) admitted that currently, the government is still in the process of drafting the related regulations.

BOND MARKET


Mixed Flow

Indonesia bond market started the day weaker and with offerish tone. In the morning session, sporadic selling interest was seen specially on 5Y and 10Y benchmark series. Selling interest was seen from onshore foreign banks. In the middle of the day, market took a U-turn as few bottom fishers came into the market and erased the morning loss. We saw some players collecting at better yield and provided some support to the market. Overall, yield lower by about 2 – 4 bps compared to yesterday closing. In the meantime, MoF announced that it will hold its first debt switch of the year tomorrow.


