# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

#### **SUSTAINED ABOVE 6,000**

JCI was relatively flat and closed at 6,010 (-2 points or - 0.04%) today. Shares across regional markets were mixed as investors were focusing on the vaccine rollout, while the virus itself continued to rage in many parts of the world. Meanwhile, foreign investors recorded net inflow of IDR 852Bn today and rupiah slightly weakened to IDR 14,120/USD.

Banking stocks were negative as BDMN (-0.88%), PNBN (-1.36%), BMRI (-0.37%), BBNI (-1.14%), and BBCA (-0.44%) all corrected. Consumer names were negative as UNVR (-0.33%), INDF (-1.78%), ICBP (-1.27%), GGRM (-2.21%), and HMSP (-1.85%) all retreated. Telco stocks were positive as TLKM (+3.92%), EXCL (+3.05%), and ISAT (+1.8%) all rose. Construction names were negative as ADHI (-1.16%), WIKA (-0.55%), WSKT (-0.83%), and PTPP (-1.86%) all declined. Other movers were IMAS (+18.97%), TINS (+5.32%), BYAN (-6.62%), and UNTR (-3.01%).

Production of nickel in Indonesia is expected to reach 800k tonnes in 2021 (+6% YoY). This constitutes 32% of total global production.

### **FLATTISH**


The bond market saw no improvement in risk sentiment today although we witnessed two ways trading in the market. Although the overall market tone was biddish, no significant price action took place. IDR bond the prices ended the day unchanged from yesterday level. Hardly any trade heard done at least from our end only 10Y FR82/15YFR80/20Y FR83 traded as high as 106.5 (6.1%)/109.55 (6.47%)/109.35 (6.63%).




