

# FOR PROFESSIONAL INVESTORS - 01/27/2023 DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

#### **INCHED UP**

JCI slightly strengthened and closed at 6,899 (+34 points or +0.5%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 919Bn today and rupiah slightly weakened to IDR 14,985/USD.

Banking stocks were mostly positive as BBCA (+2.65%), BMRI (+2.04%), BBRI (+1.09%), and BBNI (+0.79%) all closed higher, except MEGA (-0.45%). Consumer names were mostly negative as MYOR (-1.23%), GGRM (-1.68%), ICBP (-0.74%), and UNVR (-1.04%) all declined, except KLBF (+0.49%). Properties stocks were positive as CTRA (+3.74%), SMRA (+4.27%), BSDE (+2.72%), and PWON (+1.35%) all inched higher. Construction names were positive as WSKT (+9.55%), PTPP (+6.11%), ADHI (+5.19%), and WIKA (+2.94%) all closed higher. Other movers were ITMG (+2.78%), PTBA (+2.36%), ARTO (-6.98%), and BRMS (-4.66%).

The manufacturing industry recorded a total investment of Rp497.7tn in 2022, increased by +52% YoY. The biggest investment was on metal industry, food and beverages, chemical, and pharmaceutical.

## **BOND MARKET**

#### **SELLING CONTINUES**


IndoGB market traded lower today with overall yield curve closed higher by 3bps. The morning session saw a quiet market despite higher UST yields overnight following US better than expected 4Q GDP data release. However, selling interest were seen in the afternoon session mostly in 5-10Y tenor bucket. The most traded bonds today 10Y FR96 were traded as low as 101.85 (6.74%) while 11Y FR68 were traded as low as 111.8 (6.84%). By end of the day, the benchmark series of 5/10/15/20Y closed the week at mid yield 6.42%/6.74%/6.86%/6.90%




