OBJECTIVE

The THEAM QUANT - Healthy Living Opportunities fund leverages the experience of BNP Paribas Exane Research and the equity selection capabilities of BNP Paribas QIS with the ambition of identifying companies that are improving the health and well-being of people, while exhibiting high Environmental, Social and Governance (“ESG”) standards as well as robust financial fundamentals.

INVESTMENT UNIVERSE

- **IDENTIFICATION:** In-house Artificial Intelligence model used for large-scale scanning of companies’ activities
- **EXPOSURE:** Analysis of company revenues generated from each industry segment
- **ADEQUACY:** Systematic and analyst-based relevance controls of selected companies to determine final scoring

FINANCIAL FILTERS

Exclusion of companies with the weakest financial perspectives

Selects **companies that maximise the portfolio’s Healthy Living Score**, taking into account **Sustainable Investments** requirement and **diversification constraints**.

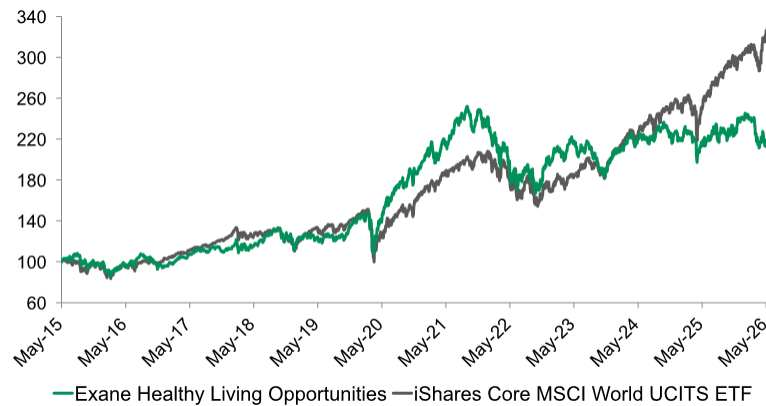

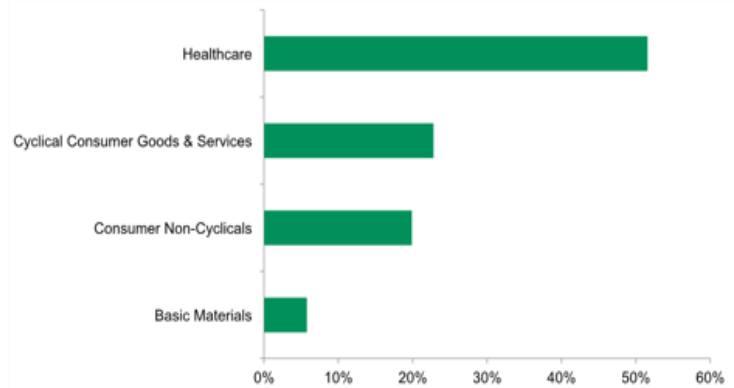
