DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

REBOUNDED

JCI advanced and closed at 6,835 (+45 points or +0.66%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 1.4Tn today and rupiah slightly strengthened to IDR 14,358/USD.

Banking stocks were mostly positive as BBCA (+2.91%), BMRI (+0.66%), BBRI (+0.23%), and BBNI (+1%) all in green, except PNBN (-3.03%). Consumer names were mixed as KLBF (+0.61%) and ICBP (+0.58%) advanced, while GGRM (-1.29%), MYOR (-2.42%), and UNVR (-1%) corrected. Material stocks were positive as TPIA (+3.43%) and BRPT (+5.41%) all closed higher. Retailer names were mostly positive as AMRT (+3.67%), MAPI (+6.08%), and ERAA (+1.83%) all rose, except ACES (-2.01%). Other movers were CPRO (+20.93%), FREN (+4.88%), MSIN (-5.84%), and NATO (-4.52%).

Bank Indonesia (BI) noted declined forex reserves in Jan-22 to US\$141.3bn due to the coal export ban, from US\$144.9bn in Dec-21.

BOND MARKET


LACKLUSTER TRADING

Bond market opened wider as price quotation continued its upward movement from yesterday. Several buying activities were seen especially on middle tenor benchmark and non-benchmark series but the trade volumes were small until the trading session end. Stronger bond was in line with that in USD/IDR as the pair closed lower at 14,355. In the meantime, market are waiting for BI rate announcement scheduled to be released tomorrow and US CPI tonight


