EQUITY MARKET

HOLDING UP

JCI slightly strengthened and closed at 6,823 (+30 points or +0.44%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR 266Bn today and rupiah slightly weakened to IDR 14,733/USD.

Banking stocks were mostly negative as MEGA (-1.26%), BBRI (-0.22%), BBNI (-0.86%), and BBCA (-1.65%) all corrected, except PNB (+3.45%). Consumer names were mostly negative as INDF (-0.77%), ICBP (-1.54%), KLBF (-1.23%), and UNVR (-2.89%) all weakened, except SIDO (+3.76%). Telco stocks were negative as ISAT (-1.77%), EXCL (-1.85%), and TLKM (-0.94%) all weakened. Infra names were negative as JSMR (-2.09%), PGAS (-1.27%), TBIG (-2.07%), and TOWR (-2.54%) all closed lower. Other movers were NFCX (+20.06%), ARTO (+19.79%), ESSA (-6.87%), and MAPI (-6.11%).

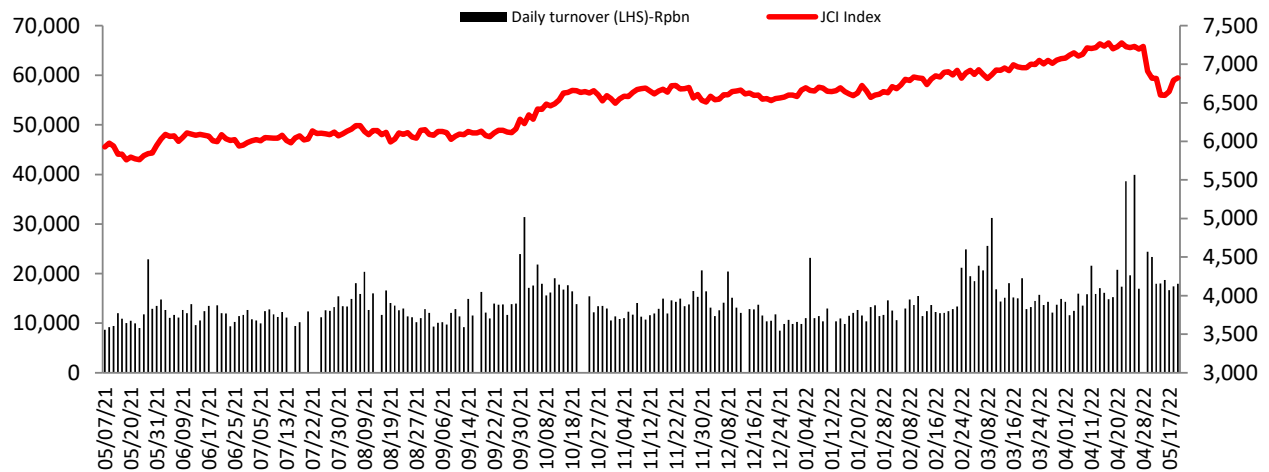

QUIET MARKET

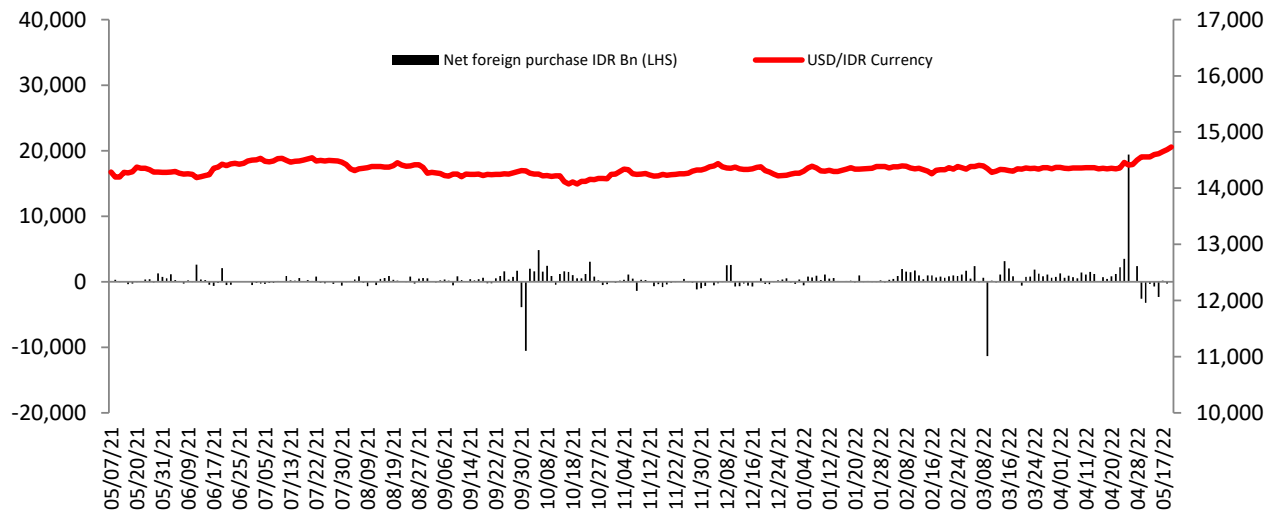
