# DAILY REPORT INDONESIA MARKET WRAP

### **EQUITY MARKET**

#### **RECOVER**

JCI slightly strengthened and closed at 7,232 (+16 points or +0.22%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.2Tn today and rupiah slightly strengthened to IDR 14,411/USD.

Banking stocks were mostly positive as BBRI (+2.07%), BBCA (+1.56%), BMRI (+1.52%), and BBNI (+1.05%) all closed higher, except BBTN (-1.61%). Consumer names were positive as UNVR (+5.42%), MYOR (+7.36%), KLBF (+1.25%), ICBP (+2.02%), and GGRM (+1.63%) all inched higher. Mining stocks were negative as ITMG (-1.87%), PTBA (-1.62%), ADRO (-1.56%), ANTM (-4.58%), and INCO (-6.8%) all closed lower. Poultry names were positive as CPIN (+2.13%), JPFA (+6.57%), and MAIN (+2.38%) all in green. Other movers were SMGR (+7.11%), BFIN (+5.62%), BBYB (-6.99%), and HRUM (-6.92%).

Bank Indonesia noted that the value of e-commerce transactions in 1Q22 grew by 19.8% YoY and volume also rose 38.4% YoY, in line with the increase in online public spending and many marketing strategies in the marketplace.

### **BOND MARKET**


#### **BETTER SENTIMENT**

Indonesia bond market closed the day with better sentiment. After bond market opened in wide spread, market players was seen biddish throughout the day with yields moved lower by 2-4 bps. Some local players was heard collecting in belly curve. Market trading was particularly active on 5Y FR90 and 10Y FR91 which remained as the most actively traded bonds for the day. The 5Y FR90 and 10Y FR91 traded as high as 95.4 (6.21%) and 95.7 (6.98%).


