Objectives and Investment Policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by Asian companies, and/or companies operating in Asia (excluding Japan), with a solid financial structure and/or potential for earnings growth.

It may be invested in Mainland China shares restricted to foreign investors such as China A shares which can be listed on a Stock Connect or through a use of a specific license granted by the Chinese authorities.


It is actively managed and as such may invest in securities that are not included in the index which is MSCI AC Asia ex-Japan (NR).

The investment team applies also BNP PARIBAS ASSET MANAGEMENT Sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria in the investments of the Fund.

Income are systematically reinvested.

- Why is the Fund in this specific category?

The risk category is justified by the investment mainly in Stocks and Shares, the value of which can fluctuate considerably. These fluctuations are often amplified in the short term.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Operational and Custody Risk:</u> Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- Risks related to Shanghai Hong Kong Stock Connect: This risk relates to
 securities trading and clearing through the Stock Connect. Stock Connect is subject
 to quota limitation which may restrict the fund's ability to invest in China AShares on a timely basis. In addition, the Stock Connect is novel in nature, the
 regulations are untested and there is no certainty as to how they will be applied,
 which may affect the fund's ability to enforce its rights and interests in the China
 A-Shares.


