DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

EXTENDED BUYING

JCI slightly strengthened and closed at 7,171 (+16 points or +0.22%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net outflow of IDR 276Bn today and rupiah was stabilized at IDR 16,360/USD.

Banking stocks were mostly positive as BBRI (+3.18%), BMRI (+2.13%), BBNI (+3.36%), and PNBN (+4.56%) all advanced, except BBCA (-2.78%). Consumer names were negative as KLBF (-0.41%), MYOR (-1.6%), UNVR (-2.23%), ICBP (-2.77%), and INDF (-2.96%) all declined. Telco stocks were mixed as FREN (+4.35%) rose, while ISAT (-1.32%) and TLKM (-1.88%) down. Cement names were positive as SMGR (+3.16%), INTP (+0.41%), SMBR (+1.03%), and SMCB (+0.67%) all in green. Other movers were PYFA (+34.48%), CMNP (+22.22%), HEAL (-4.08%), and AMRT (-2.11%).


Within Range

It was dull trading day for bond market with hardly any trade heard done at least from our end. Investors shied away ahead of auction tomorrow and Trump's inauguration tonight. There will be fresh supply tomorrow after BI surprise cut last week. Indonesia Debt Management Office ("DMO") will hold conventional bond auction with IDR 26Tn issuance target. The series that will be issued are 3M SPN, 12M SPN, 5Y FR104, 10Y FR103, 15Y FR106, 20Y FR107, 30Y FR102 and 40Y FR105. In the previous conventional auction, incoming bids reached IDR 31.65Tn and DMO issued IDR 26.2Tn


