# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

#### **HOLDING UP**

JCI slightly strengthened and closed at 5,849 (+7 points or +0.12%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 1.3Tn today and rupiah was stabilized at IDR 14,285/USD.

Banking stocks were mostly positive as BBRI (+3.04%), BBCA (+1.12%), BMRI (+0.87%), and BBNI (+0.97%) all closed higher, except BDMN (-0.85%). Consumer names were mostly negative as INDF (-0.4%), ICBP (-1.81%), HMSP (-1.16%), and UNVR (-0.86%) all down, except KLBF (+1.41%). Telco stocks were negative as FREN (-1.11%), EXCL (-1.26%), and TLKM (-3.25%) all retreated. Infra names were mixed as PGAS (+0.89%) and JSMR (+0.78%) advanced, while TBIG (-1.65%) and TOWR (-5.24%) corrected. Other movers were HERO (+24.91%), SCMA (+9.38%), SUPR (-6.77%), and BMAS (-6.74%).

## **BOND MARKET**


#### WITHIN RANGE

The mixed sentiment was seen in the bond market today with the bond price opened around the same level as yesterday's closing. We witnessed several sporadic activity although the volume was very limited. Overall, IDR bonds yield higher 1 – 2 bps compared to yesterday closing, but IDR bonds still traded within range. The benchmark of 5Y, 10Y and 15Y closed at mid yields of 5.52%, 6.43% and 6.35% respectively. Spot closed at 14310.


