# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

### **Slight Rebound**

JCI slightly strengthened and closed at 6,803 (+15 points or +0.22%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net outflow of IDR 788Bn today and rupiah slightly strengthened to IDR 16,305/USD.

Banking stocks were mostly negative as PNBN (-3.66%), BBRI (-0.51%), BBNI (-3.59%), and BMRI (-1.46%) all retreated, except BNLI (+14.68%). Consumer names were mostly negative as GGRM (-1.51%), ICBP (-0.43%), UNVR (-4.44%), and INDF (-3.45%) all corrected, except KLBF (+0.83%). Material stocks were positive as TPIA (+2.88%) and BRPT (+1.19%) all inched higher. Mining names were mostly negative as PTBA (-0.37%), INDY (-4.56%), ADRO (-0.91%), and ANTM (-3.86%) all weakened, except INCO (+4.45%). Other movers were DWGL (+24.44%), STTP (+5.65%), MSIN (-9.32%), and CMNP (-8.68%).

Indonesia's Balance of Payments (BOP) recorded a USD7.9 billion surplus in the fourth quarter of 2024, increasing from a USD5.9 billion surplus in the third quarter of 2024.

### **BOND MARKET**


#### TWO WAY INTEREST

The mixed sentiment was seen in the bond market today with the bond price opened around the same level as yesterday's closing. Market saw mixed flow during the day as investor interest focused on 5Y – 10Y series. Prices moved in tight range with overall biddish market tone was dominated by onshore names while onshore foreign names tried to book profit. The 5Y/10Y yield higher by about 1 – 5bps compared to yesterday closing, while the rest of the curved moved up by 1 - 2 bps.


