# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

#### **Volatile Closing**

JCI slightly weakened and closed at 7,077 (-35 points or 0.5%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net outflow of IDR 120Bn today and rupiah weakened to IDR 15,263/USD.

Banking stocks were mixed as BBCA (+0.3%) and PNBN (+1.29%) closed higher, while BBRI (-0.22%), MEGA (-3.04%), and BMRI (-0.53%) closed lower. Consumer names were mixed as GGRM (+6.78%) and HMSP (+3.95%) in green, while ICBP (-0.56%), INDF (-0.81%), and KLBF (-1.62%) declined. Mining stocks were negative as INDY (-2.93%), ITMG (-1.2%), ANTM (-2.04%), ADRO (-1.02%), and INCO (-4.94%) all declined. Cement names were negative as SMCB (-1.32%), SMBR (-3.85%), INTP (-0.51%), and SMGR (-1.33%) all down. Other movers were MIDI (+10.44%), SSMS (+3.03%), ESSA (-6.98%), and BRMS (-6.63%).

The government has distributed wage subsidy assistance (BSU) 2022 to about 7mn workers or 48.3% of the total 16.4mn workers.

### **BOND MARKET**


#### **UNCHANGED SENTIMENT**

The bond market was quiet for most part of the trading day although the overall sentiment was quiet bleak. Bonds prices across the board underwent pressure following UST spike to 4% last night. Local currency also weakened further despite intervention from BI, closing the day at 15275/80 against USD. From our side we heard 5Y FR90 traded at 93.65 (6.77%) while 11Y FR96 down to 97 (7.41%). By end of day, yield curve moved higher with 5Y/10Y/15Y/20Y yield moved by -4/+9/+2/+4 respectively.


