INDONESIA MARKET WRAP

EQUITY MARKET

Sharp Rebound

JCI advanced and closed at 6,520 (+249 points or +3.97%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR - 2.9Tn today and rupiah advanced to IDR 16,480/USD.

Banking stocks were positive as BBRI (+9.23%), BMRI (+6.52%), BBKA (+4.45%), BBNI (+5.71%), and BNL (+5.5%) all closed higher. Consumer names were positive as INDF (+3.16%), UNVR (+10.84%), KLBF (+2.78%), ICBP (+1.2%), and SDO (+3.6%) all closed higher. Retailer stocks were positive as AMRT (+7.27%), MAPA (+3.75%), ERAA (+7.14%), and ACES (+3.88%) all up. Material names were positive as TPIA (+11.19%) and BRPT (+4.46%) all up. Other movers were MDKA (+8.93%), BRMS (+7.34%), SRAJ (-11.97%), and LIFE (-10.34%).

Government is giving discounts of 13-14% on domestic flight ticket prices and around 20% for toll road tariffs for the homecoming activities in the upcoming Lebaran period.

BOND MARKET

Unchanged Sentiment

Indonesia bond market closed the week with unchanged sentiment despite Rupiah weakening against USD, traded above 16,550 level. Market is still moving two ways in the morning session, although in the second session bond market was pretty quiet. Trading concentrated on front to middle maturities while the other part of the yield curve was quoted within range throughout the day. IDR bond the prices ended the day unchanged from yesterday level. The 5Y/10Y/15Y/20Y benchmark closed the week at mid yield of 6.72%/6.90%/7%/6.99%. Spot closed at 16,596.

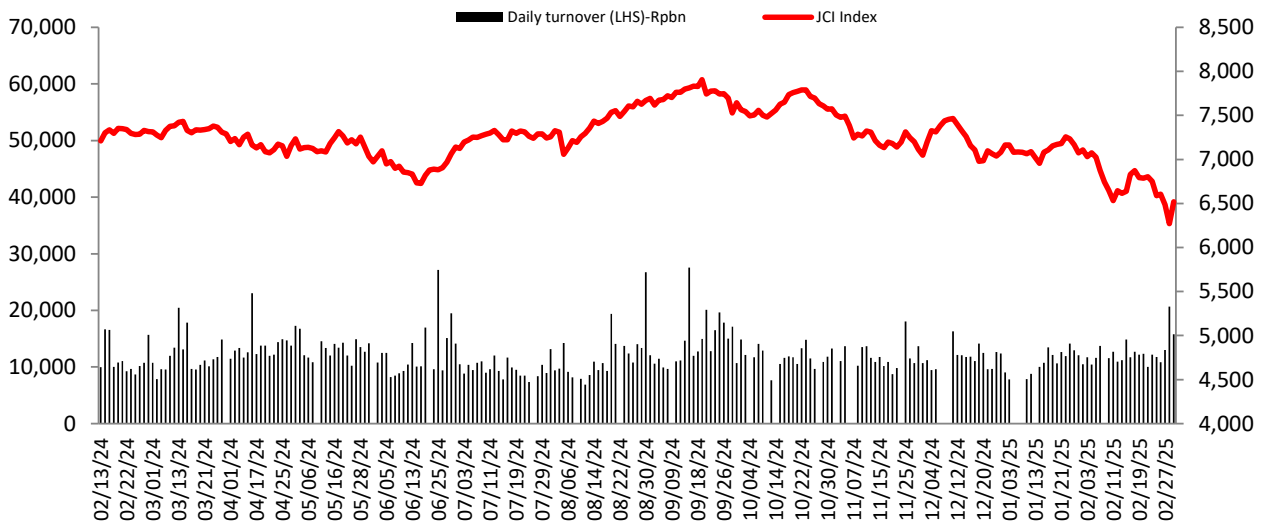

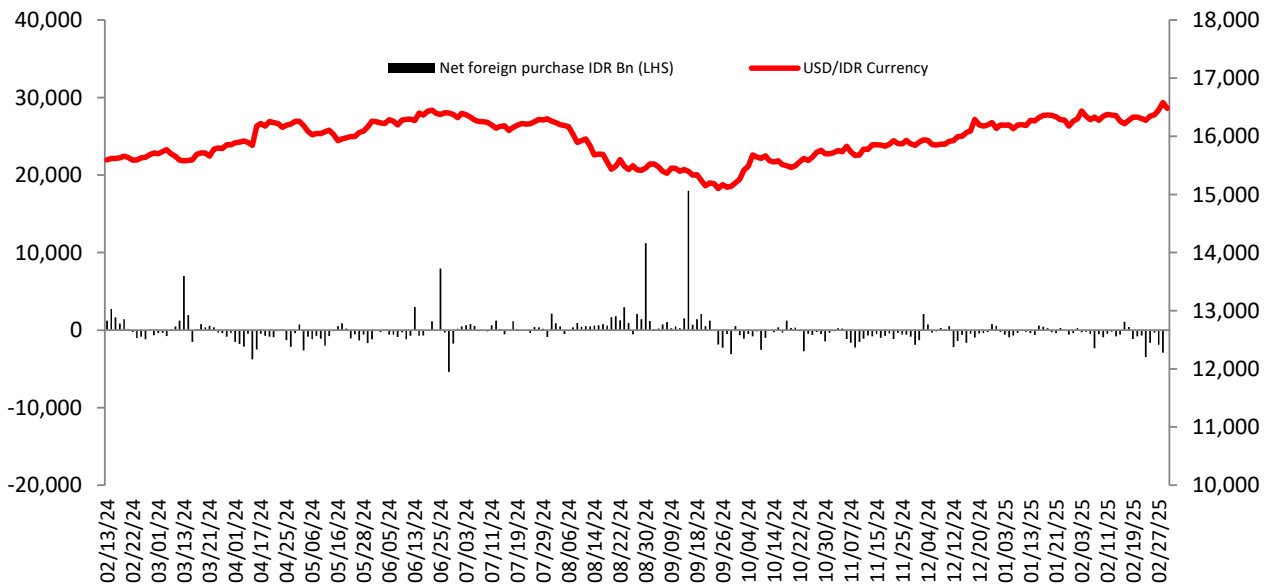
