INDONESIA MARKET WRAP

EQUITY MARKET

Slightly Higher

JCI was flat and closed at 7,338 (+7 points or +0.1%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 556Bn today and rupiah slightly strengthened to IDR 15,660/USD.

Banking stocks were mixed as BBTN (+4.4%), MEGA (+0.4%), and BDMN (+0.68%) inched higher, while PNB (-0.46%) and BBNI (-1.28%) closed lower. Consumer names were mostly negative as INDF (-0.39%), UNVR (-1.45%), KLBF (-1.35%), and ICBP (-2.45%) all down, except MYOR (+2%). Mining stocks were positive as ANTM (+2.41%), INCO (+3.65%), TINS (+11.04%), PTBA (+2.08%), and INDY (+2.07%) all inched higher. Telco names were negative as EXCL (-1.64%), ISAT (-3.35%), and TLKM (-1.02%) all declined. Other movers were BBYB (+11.11%), MPRO (+6.27%), DSNG (-8.21%), and MIKA (-3.64%).

The General Election Commission (KPU) ratified the results of the 2024 elections, with Prabowo Subianto-Gibran Rakabuming winning the presidential election.

BOND MARKET

WITHIN RANGE

JCI slightly strengthened and closed at 7,433 (+12 points or +0.16%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.9Tn today and rupiah was stabilized at IDR 15,582/USD.

Banking stocks were mixed as BBKA (+3.25%) and BMRI (+1.72%) in green, while MEGA (-3.83%), BBNI (-1.2%), and BBRI (-3.91%) retreated. Consumer names were mixed as INDF (+1.98%), ICBP (+1.63%), and KLBF (+0.7%) advanced, while MYOR (-1.25%) and UNVR (-1.1%) retreated. Mining stocks were positive as ADRO (+2.69%), PTBA (+2.86%), ANTM (+1.54%), ITMG (+1.48%), and INDY (+3.93%) all in green. Material names were mixed as BRPT (+0.98%) up, while TPIA (-10.84%) declined. Other movers were DSSA (+15.48%), MEDC (+9.02%), BRIS (-4.91%), and PANI (-3.67%).

Consumer optimism is decreasing ahead of the Ramadan momentum, as indicated by the decline in the Consumer Confidence Index (CCI) based on the results of the Bank Indonesia Consumer Survey. On Feb-24, the CCI was recorded at level 123.1, down from Jan's level of 125.

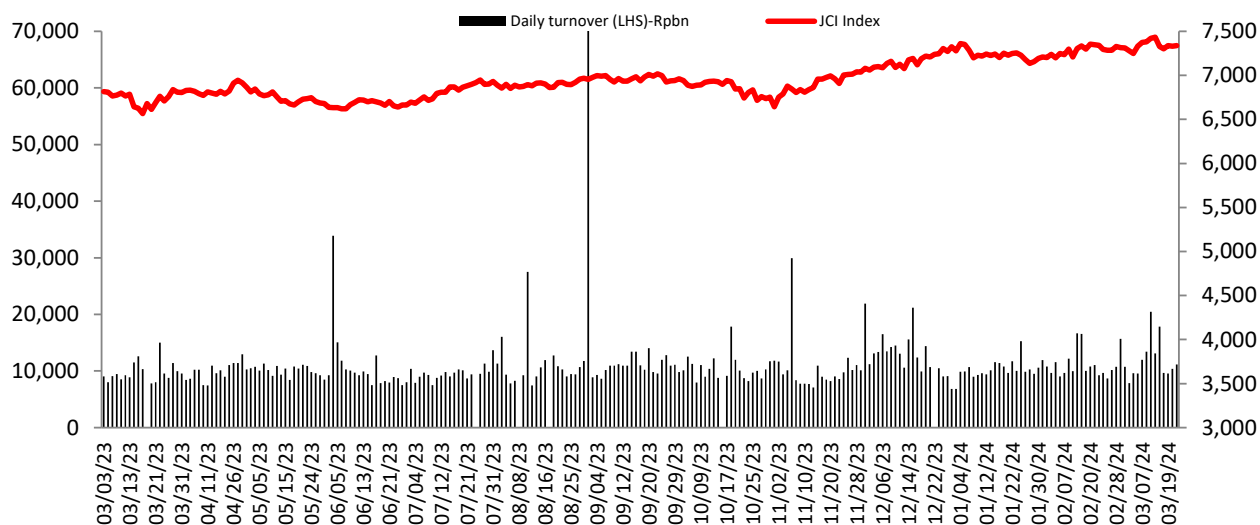

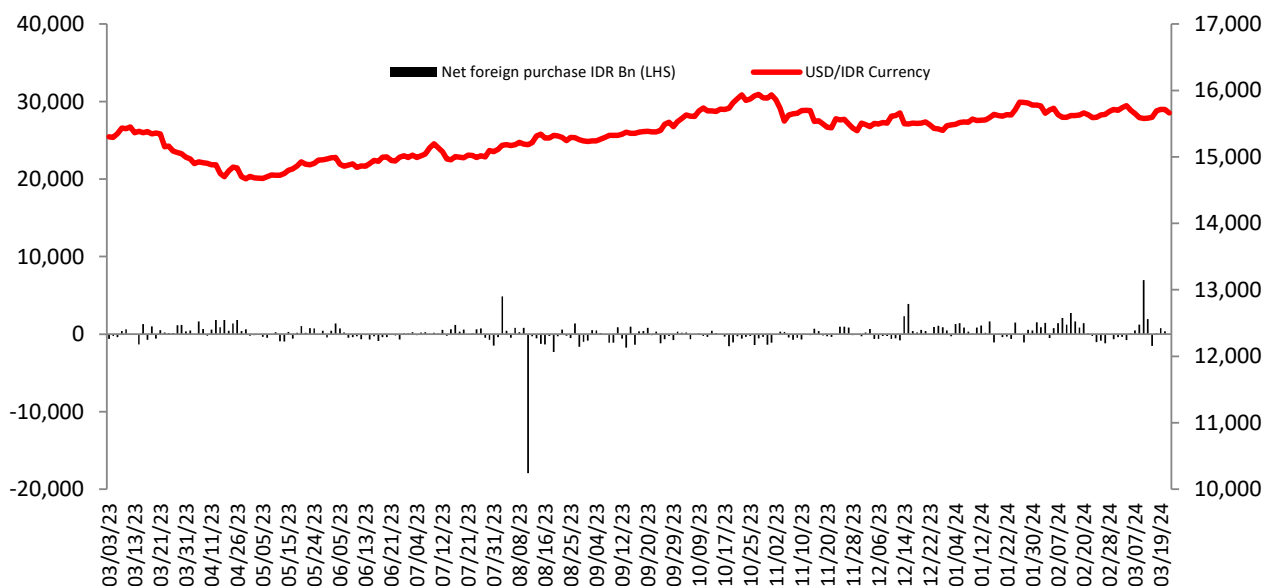
