## INDONESIA MARKET WRAP

---

### EQUITY MARKET

#### Further Rally

JCI advanced and closed at 8,934 (+74 points or +0.84%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 591Bn today and rupiah was stabilized at IDR 16,750/USD.

Banking stocks were mixed as BBCA (+1.24%), BBRI (+1.38%), and BBNI (+0.24%) inched higher, while BNLI (-1.43%) and BMRI (-3.37%) weakened. Consumer names were mostly positive as INDF (+2.19%), HMSP (+2.68%), GGRM (+3.68%), and UNVR (+1.16%) all inched higher, except KLBF (-2.45%). Pulp & paper stocks were positive as INKP (+7%) and TKIM (+6.42%) all rose. Telco names were negative as EXCL (-0.52%), ISAT (-7.3%), and TLKM (-1.68%) all closed lower. Other movers were BIPI (+34.68%), BSIM (+24.86%), CPRO (-13.95%), and PNLF (-8.38%).

The Central Bureau of Statistics (BPS) noted that Indonesia's trade balance recorded a surplus in Nov25 of US\$ 2.7 billion, or an increase of US\$ 0.27 billion compared to the previous month which was US\$ 2.4 billion.

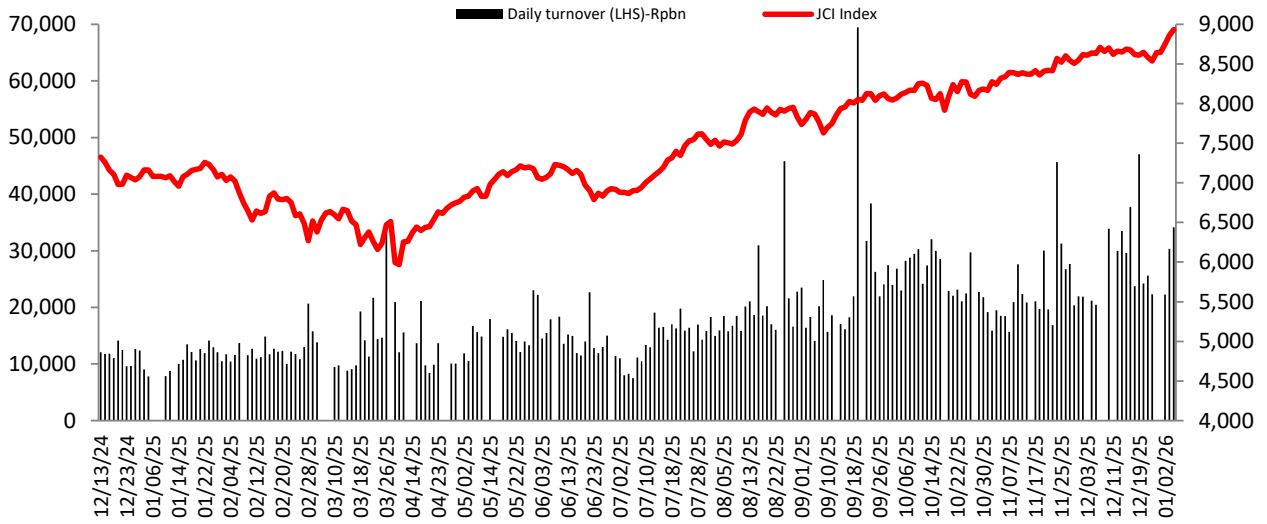
### BOND MARKET

#### 1st Auction in 2026

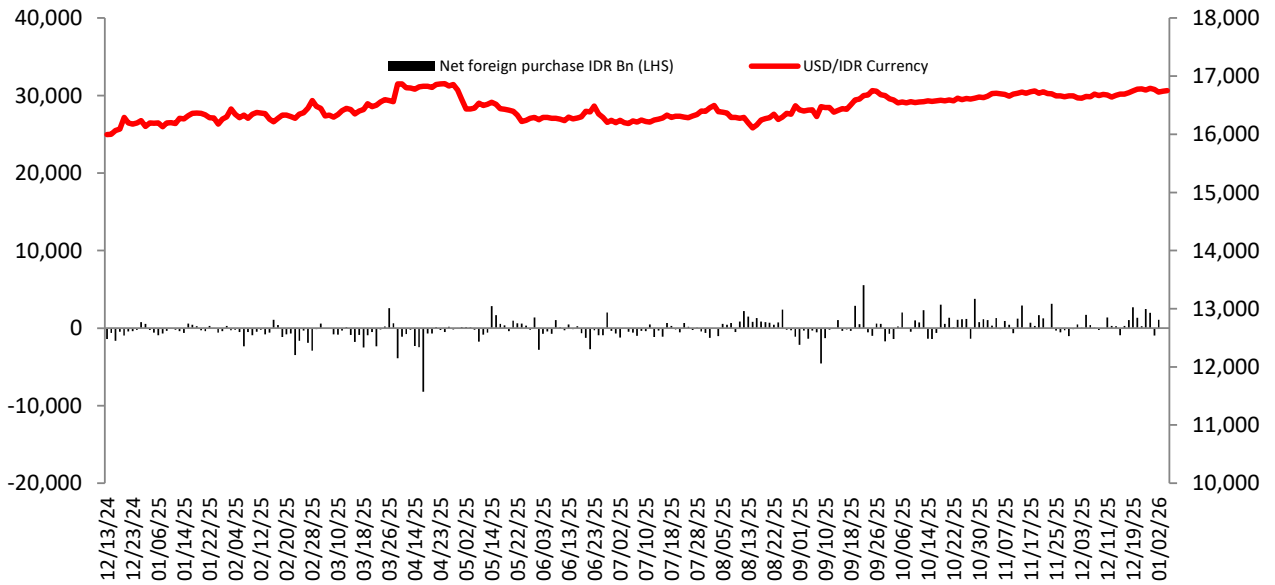
The bond market closed the day unchanged despite today is 1st auction in 2026. Narrow bid and ask spread quoted throughout the day, no significant trade was heard at least from our side. Nothing much changed in today's trading activity despite Rupiah weakening traded above 16,770. In today auction, government only received incoming bids totaling at IDR 90.963Tn, out of which MoF managed to issue IDR 40Tn from initial target IDR 33Tn. The series absorbed (against incoming bids) on the auction were IDR 2.4Tn (IDR 6.8Tn) 1mo SPN, IDR 1.75Tn (IDR 8.95Tn) 3mo SPN, IDR 5Tn (IDR 17.04Tn) 12mo SPN, IDR 6.55Tn (IDR 10.78Tn) 5Y FR109, IDR 7.3Tn (IDR 14.945Tn) 10Y FR108, IDR 5.4Tn (IDR 16.352Tn) 15Y FR106, IDR 5.2Tn (IDR 7.673Tn) 20Y FR107, IDR 3.05Tn (IDR 4.559Tn) 30Y FR102 and IDR 3.35Tn (IDR 3.861Tn) 40Y FR105 at weighted average yields of 4.63%, 4.7%, 4.82%, 5.44%, 6.08%, 6.36%, 6.49%, 6.7% and 6.75% respectively. Rupiah closed at 16,758.
