DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Flat

JCI was flat and closed at 6,891 (+3 points or +0.04%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 86Bn today and rupiah weakened to IDR 15,690/USD.

Banking stocks were mostly negative as MEGA (-0.47%), BBNI (-1.92%), BBRI (-0.97%), and BMRI (-2.07%) all corrected, except BBCA (+0.28%). Consumer names were negative as MYOR (-1.12%), INDF (-0.36%), UNVR (-2.11%), ICBP (-3.48%), and KLBF (-3%) all corrected. Mining stocks were positive as ADRO (+4.53%), ANTM (+5.54%), INCO (+2.71%), PTBA (+2.26%), and ITMG (+1.98%) all closed higher. Material names were negative as TPIA (-1.82%) and BRPT (-4.8%) all down. Other movers were ESSA (+11.19%), MEDC (+9.67%), PANI (-5.88%), and JPFA (-3.32%).

Indonesia forex reserve fell 1.6% MoM to US\$135bn in Sep-23. This is equivalent to financing 6.1 months of imports or 6.0 months of imports and servicing the gov't's external debt

BOND MARKET


Mixed Interest

After strong US NFP last Friday, Indonesia bond market trading two ways today. Some buying interest was seen in the morning session due to short covering. Market witnessed trading flow particularly in the belly to tail part of the curve with yield seen 3 – 10 bps lower. Today, US, Japan, and Hong Kong market closed. In the afternoon session, we did see some profit taking actions while Bank Indonesia still watching the market with Rupiah touched 15,700 level. Overall, the 5Y/10Y/15Y/20Y benchmark yield closed the day with yield movement +2/+1/-1/-3. Tomorrow on Oct 10 MoF will hold the regular Sukuk auction. The series offered are 6M SPNS, 2Y PBS-036, 4Y PBS-03, 13Y PBS-037, 16Y PBS-034 and 24Y PBS-033 with indicative target of IDR 9Tn.


