# DAILY REPORT INDONESIA MARKET WRAP

### **EQUITY MARKET**

#### **Rally**

JCI advanced and closed at 7,257 (+75 points or +1.05%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 293Bn today and rupiah slightly strengthened to IDR 16,285/USD.

Banking stocks were positive as BMRI (+1.65%), BBNI (+1.05%), BBCA (+0.26%), MEGA (+1.06%), and PNBN (+2.43%) all advanced. Consumer names were mostly positive as ICBP (+3.41%), INDF (+2.35%), KLBF (+1.61%), and MYOR (+2.87%) all rose, except UNVR (-2.02%). Telco stocks were positive as TLKM (+3.8%), ISAT (+0.44%), and EXCL (+0.44%) all advanced. Material names were positive as TPIA (+3.33%) and BRPT (+1.09%) all inched higher. Other movers were JSPT (+19.89%), AMRT (+6.62%), PTRO (-3.83%), and MAPA (-3.17%).

The government will extend the natural gas price cap (HGBT) which ended in December 2024. Two ministers, namely Coordinating Minister for Economic and Economic Affairs Airlangga Hartanto and Minister of Industry Agus Gumiwang have confirmed.

## **BOND MARKET**


#### **SOFTER**

Indonesia bond market closed the day with lower yield around 3 – 7 bps. Most of the morning session was muted with bidders turned very defensive. In the afternoon session, buying interest was seen. Market saw buying interest at the front and belly of the curve which 5Y – 15Y areas of benchmark and non-benchmark series. Positive sentiment came from offshore via onshore foreign banks and local also. The 5Y/10Y/15Y/20Y benchmark closed the day at midyield of 6.84%/7.04%/7.23%/7.22%.


