INDONESIA MARKET WRAP

EQUITY MARKET

Flat on Close

JCI was flat and closed at 6,935 (+2 points or +0.02%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 1.76Tn today and rupiah slightly weakened to IDR 15,370/USD.

Banking stocks were mixed as BBRI (+0.47%) and BBNI (+0.54%) up, while BBKA (-0.27%), BMRI (-0.43%), and MEGA (-4.31%) closed lower. Consumer names were mostly negative as MYOR (-0.38%), GGRM (-0.62%), UNVR (-0.83%), and KLBF (-1.92%) all retreated, except INDF (+0.73%). Pulp & paper stocks were positive as INKP (+3.68%) and TKIM (+1.73%) all inched higher. Material names were positive as TPIA (+2.9%) and BRPT (+0.42%) all closed higher. Other movers were PANI (+13.25%), PGAS (+6.69%), FREN (-7.58%), and BUMI (-4.41%).

The government increased the ongoing retail bond sales target (SR019 series) to Rp25tn from previously Rp20tn. The additional quota of Rp5tn is for the 3 year tenor, bringing the total target to Rp15tn, while the quota for the 5 year tenor remains the same at Rp10tn.

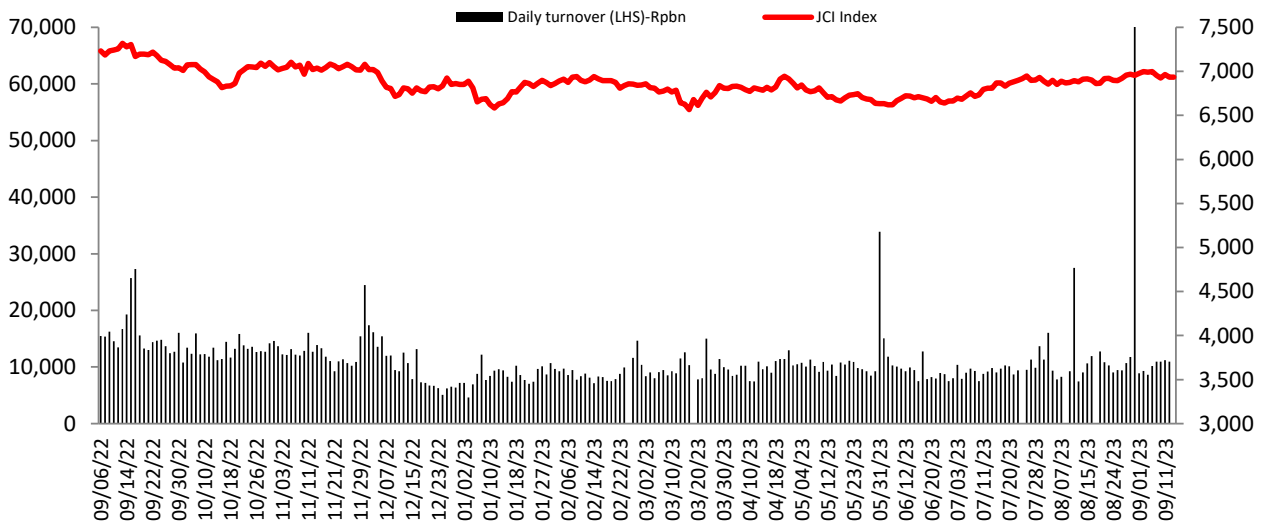
BOND MARKET

SLOW DAY

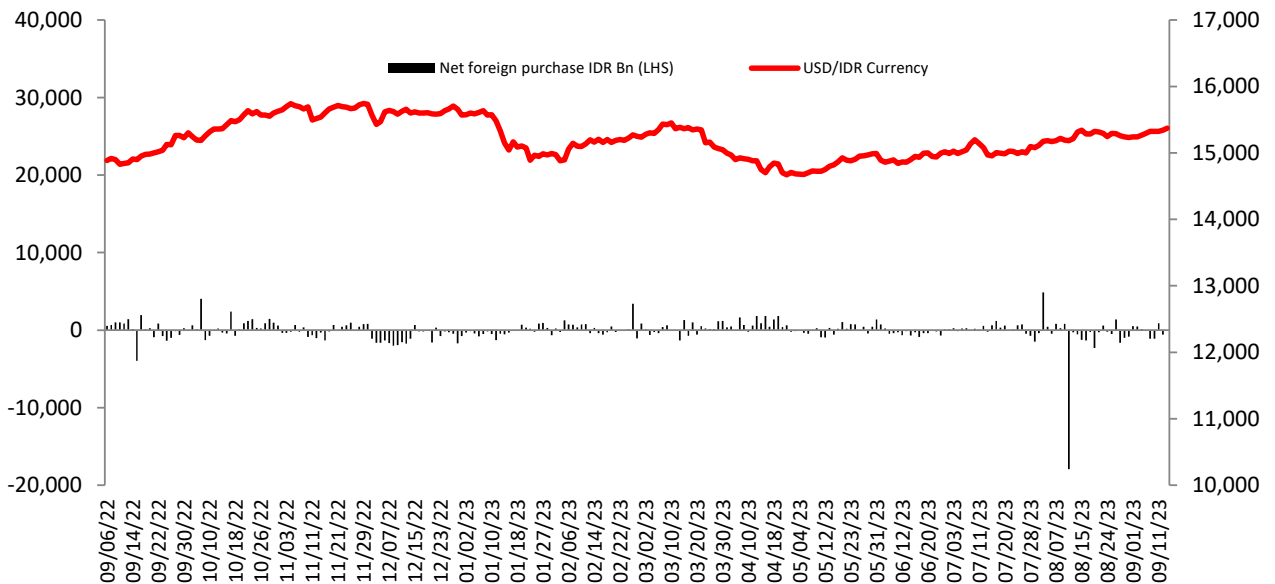
Bond market opened the day softer and wider as bidders were in defensive mode ahead US CPI data. Some biddish tone from local banks and interbank were seen on the bid side, especially on 10Y tenor, FR96 and FR100 and small activity in long tenor. Overall market was relatively quiet with small trades on benchmark series. By the end of day yield curve closed slightly lower by 1 – 2 bps. Offshore ownership dropped 4Tn last week to 842Tn.
