DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Edged Higher

JCI advanced and closed at 6,789 (+37 points or +0.55%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 309Bn today and rupiah advanced to IDR 15,728/USD.

Banking stocks were mostly positive as BBRI (+2%), BBCA (+0.56%), MEGA (+1.9%), and BBNI (+0.41%) all up, except BMRI (-1.27%). Consumer names were mostly negative as MYOR (-0.76%), KLBF (-0.31%), UNVR (-1.11%), and INDF (-1.54%) all weakened, except ICBP (+0.97%). Mining stocks were positive as ADRO (+4.18%), INCO (+1.65%), ITMG (+0.89%), INDY (+1.59%), and ANTM (+0.3%) all in green. Material names were positive as BRPT (+4%) and TPIA (+1.35%) all up. Other movers were ARTO (+11.8%), EMTK (+4.9%), NATO (-24.64%), and MPRO (-13.85%).

President Jokowi expects Rp45tn of investment will soon enter to the new capital city (IKN) project in East Kalimantan. He also noted that the current development progress remains on track with schedule.

BOND MARKET


Biddish Tone

Bond market opened firmer post FOMC meeting last night. The Fed kept policy rate unchanged and during the press conference, Chair Powell stated that the FOMC had not discussed any rate cuts yet, while the primary focus remains on whether the central bank will need to implement additional rate hikes. Risk on sentiment were seen in the local market in line with lower UST yield. However, the rally was halted by profit taking actions. The 2Y FR81 outperformed the most and was taken at 6.494% lowest. Overall yield curve moved lower by 6 – 17 bps.


