## INDONESIA MARKET WRAP

---

### EQUITY MARKET

#### Lower Again

JCI weakened and closed at 7,137 (-41 points or -0.57%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 1.05Tn today and rupiah was stabilized at IDR 15,820/USD.

Banking stocks were mixed as BMRI (+0.4%) and BBNI (+0.46%) in green, while MEGA (-0.48%), BBCA (-1.58%), and BBRI (-1.81%) closed lower. Consumer names were mixed as ICBP (+0.44%) and INDF (+0.39%) advanced, while MYOR (-0.85%), HMSP (-2.26%), and KLBF (-2.22%) weakened. Material stocks were negative as BRPT (-2.82%) and TPIA (-2.26%) all down. Pulp & paper names were positive as INKP (+3.95%) and TKIM (+0.38%) all up. Other movers were SMMA (+9.95%), MPRO (+9.05%), TCPI (-6.17%), and BRMS (-5.19%).

The Government is considering to increase the highest retail price (HET) for the subsidised cooking oil under brand 'Minyakita' from previously Rp14,000 to Rp15,000 per litre.


### BOND MARKET

#### A QUIET DAY


Indonesia bond market opened quiet today with levels similar to yesterday closing. Not much trades heard throughout the day, but we hear BI became standby buyer today in the market for 10Y FR100. 10Y FR100 were last traded at 100 (6.62%) while 5Y FR101 closed at yield 6.56%. Overall, the market tone were rather defensive ahead of FOMC meeting next week. As of 25 Jan 2024, the offshore holding in IndoGB were recorded at IDR 849.17tn or 14.89% of total IndoGB ownership.
