DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

INTRADAY HIGH

JCI advanced and closed at 4,967 (+52 points or +1.07%) today. Shares across regional markets were positive as virus shot from Pfizer, BioNtech shows promise in early test. Meanwhile, foreign investors recorded net outflow on 17th day of IDR 210Bn today and rupiah weakened to IDR 14,378/USD.

Banking stocks were mostly positive as BBCA (+1.21%), BBNI (+1.1%), BMRI (+0.2%), and BDMN (+1.47%) all inched higher, except BNLI (-0.39%). Consumer names were mostly positive as UNVR (+3.21%), ICBP (+3.8%), KLBF (+2.05%), and HMSP (+0.31%) all up, except SIDO (-1.99%). Properties stocks were positive as PWON (+3.88%), CTRA (+6.61%), BSDE (+4.83%), and SMRA (+7.5%) all closed higher. Construction names were positive as PTPP (+11.36%), WIKA (+5.15%), WSKT (+5%), and ADHI (+9.92%) all up. Other movers were TKIM (+9.7%), INCO (+5%), NATO (-6.67%), and BALI (-6.15%).

Central Bureau of Statistics (BPS) records inflation level of 0.18% in Jun 2020. This level is higher than the level during Ramadhan and Eid Al-Fitr on Apr and May level of 0.08% and 0.07% respectively.

BOND MARKET


FLATTISH

The bond market saw no improvement in risk sentiment today although we witnessed two ways trading in the market. Morning session saw selling interest started by onshore foreign players. While on the afternoon session as we witnessed several names showed their buying interest particularly after London opened although trading volume remained thin. Thin trading volume during the day pushed bidders to be more defensive with Rupiah weakening against USD. Price movement went back to range bound.


