DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

DOWN

"JCI weakened and closed at 6,228 (-65 points or -1.03%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR 103Bn today and rupiah weakened to IDR 14,020/USD.

Banking stocks were mostly negative as BBNI (-3.15%), BBRI (-0.86%), BBCA (-0.58%), and BMRI (-1.93%) all declined, except MEGA (+3.39%). Consumer names were mostly negative as GGRM (-0.91%), KAEF (-4.01%), MYOR (-3.08%), and HMSP (-1.43%) all declined, except UNVR (+1.07%). Mining stocks were negative as PTBA (-1.54%), TINS (-5.15%), ADRO (-2.48%), INCO (-2.41%), and ANTM (-4.18%) all corrected. Material names were negative as TPIA (-2.23%) and BRPT (-6.03%) all down. Other movers were KPIG (+8.15%), SRTG (+6.25%), ASII (-2.11%), and TLKM (-1.87%).

The BOD consists of: Ridha Wirahadikusumah (ex-CEO of BNLI) as CEO, Arief Budiman (ex-CFO of Pertamina) as Deputy CEO, Stefanus Ade Hadiwidjaja (Creador's Managing Director) as CIO, Marita Alisjahbana (Citi's Indonesia Country Risk Manager) as CRO, and Eddy Porwanto (ex-CFO of GIAA) as CFO."

HIGHER YIELD


Indonesia bond market closed the day with higher yield around 17 – 20 bps followed by rupiah broke above 14,000 and UST touched at 1.30%. Selling pressure from interbank and foreign names remained thick in the air. Although we saw few bottom fishers came into the market, the buying failed to lend a support as prices went further south. In the meantime, market players are waiting for BI rate announcement scheduled to be released tomorrow. The 5Y FR86/10Y FR87/15Y FR80/20Y FR83 closed the day at mid yield of 5.52%/6.45%/6.27%/7.03%




