INDONESIA MARKET WRAP

EQUITY MARKET

Lower

JCI slightly weakened and closed at 7,227 (-26 points or -0.35%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 402Bn today and rupiah was stabilized at IDR 15,615/USD.

Banking stocks were mixed as BBRI (+0.87%), BBTN (+1.5%), and PNB (+1.35%) advanced, while BBNI (-0.9%) and BBCA (-0.52%) down. Consumer names were mixed as ICBP (+2.44%), INDF (+1.18%), and MYOR (+1.27%) up, while UNVR (-1.82%) and KLBF (-1.58%) retreated. Hospital stocks were negative as MIKA (-0.39%), SILO (-2.26%), and HEAL (-1.1%) all corrected. Material names were mixed as TPIA (+2.11%) in green, while BRPT (-2.25%) corrected. Other movers were DSSA (+5.97%), CASA (+5.11%), EMTK (-3.6%), and TBIG (-3.17%).

Ministry of public works and housing (PUPR) is set to start tender offer for Pontianak-Pelabuhan Kijing soon after the feasibility study has been completed by the Toll Road Authority (BPJT).

Indonesia bond market closed the week with lower yield around 2 – 3 bps. Buying interest was seen throughout the day but the trade volumes were small until the trading session end. Market saw buying interest at the front and belly to tail part of the curve which 5Y – 10Y areas of benchmark and non-benchmark series. Positive sentiment came from foreign banks. The 5Y/10Y/15Y/20Y benchmark closed the week at mid-yield of 6.44%/6.59%/6.72%/6.84%.

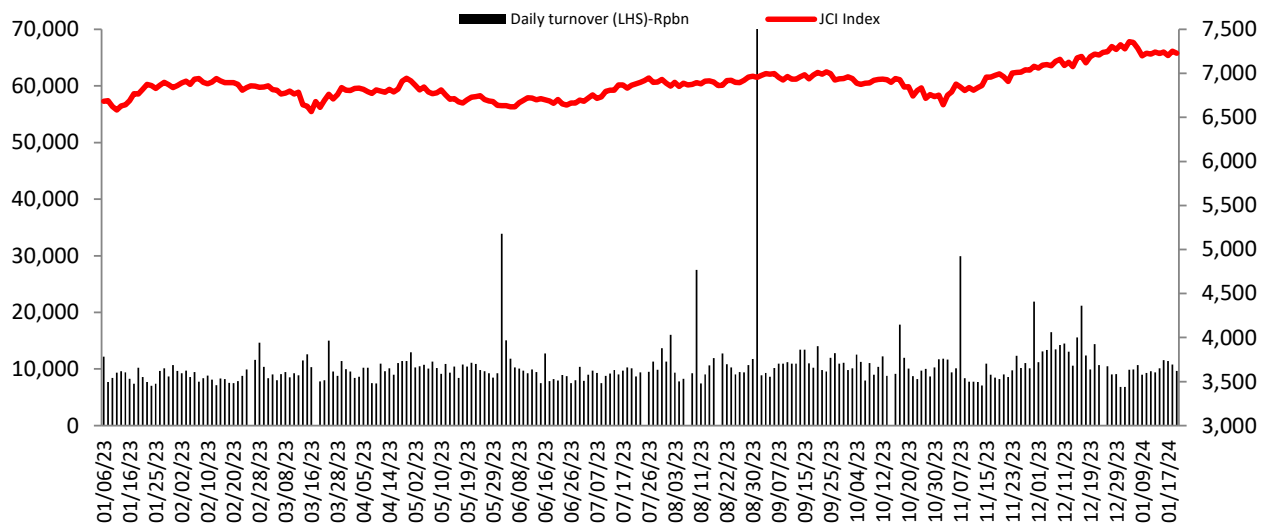

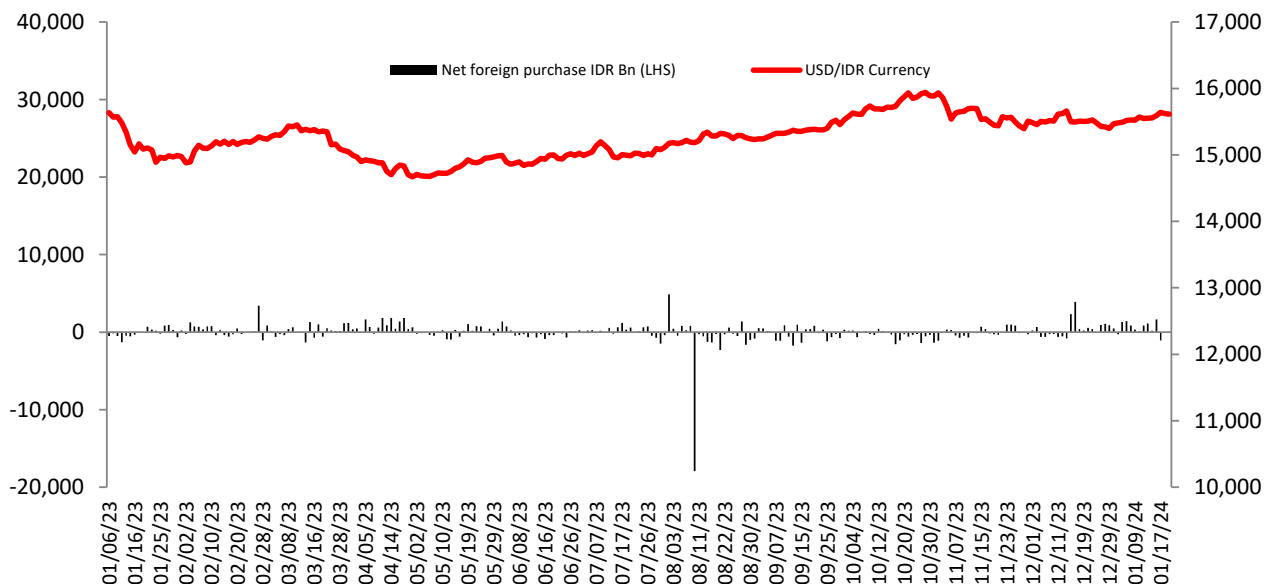
