# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

## **Continued Higher**

JCI advanced and closed at 7,531 (+62 points or +0.83%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 175Bn today and rupiah was stabilized at IDR 16,287/USD.

Banking stocks were positive as BBRI (+3.95%), BMRI (+2.56%), BBCA (+0.89%), BBNI (+2.93%), and BBTN (+2.1%) all closed higher. Consumer names were mixed as KLBF (+1%), MYOR (+1.49%), and UNVR (+0.96%) advanced, while HMSP (-1.64%) and ICBP (-0.96%) down. Material stocks were positive as TPIA (+0.55%) and BRPT (+0.45%) all inched higher. Hospital names were mixed as MIKA (+0.82%) and SILO (+0.47%) inched higher, while HEAL (-5.17%) closed lower. Other movers were ESSA (+8.77%), BBHI (+6.67%), EMTK (-3.28%), and PANI (-2.84%).

Gaikindo targets car sales at GIIAS 2025 to be the same as the achievement in 2024, reaching 40k units with transaction value reaching Rp20tn.

# **BOND MARKET**


## **WITHIN RANGE**

Indonesia bond market opened with wide spread as players turned defensive. Only few trades were seen in the morning session. While on the afternoon session as we witnessed mixed names showed their selling interest particularly after London opened although trading volume remained thin. Thin trading volume during the day pushed bidders to be more defensive. Price movement went back to range bound lacking fresh catalyst. Both offshore and onshore names interests remained focused on front to mid-dated bonds although trading on other part of the curve was heard as well.


