DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

REBOUNDED

JCI advanced and closed at 6,821 (+52 points or +0.77%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 1.58Tn today and rupiah was stabilized at IDR 15,588/USD.

Banking stocks were mostly negative as PNBN (-3.14%), BBNI (-1.06%), BMRI (-0.5%), and BBRI (-0.41%) all weakened, except BBCA (+1.17%). Consumer names were mixed as SIDO (+1.32%) and UNVR (+0.21%) advanced, while GGRM (-2.41%), ICBP (-0.73%), and INDF (-1.08%) weakened. Material stocks were positive as TPIA (+1.23%) and BRPT (+0.65%) all inched higher. Properties names were negative as BSDE (-1.08%), SMRA (-1.63%), PWON (-1.35%), and CTRA (-2.62%) all weakened. Other movers were BYAN (+13.19%), BRIS (+4.55%), PNLF (-6.5%), and BBYB (-6.02%).

State budget deficit narrowed in Nov-22 to Rp67.4tn from Rp230.4tn in Oct-22. Cumulatively, 11M22 deficit reached Rp236.9tn or equiv. to (-)1.21% of GDP, lower compared to 11M21 deficit at (-)3.63%. 11M22 revenue reached Rp2,378tn (98% of FY22 outlook), while expenditure reached Rp2,614tn (82% of FY22 outlook).

BOND MARKET


RELATIVELY UNCHANGED

IDR bond market still traded quietly today as there was no new catalyst to move the market. Some selling interest were seen in the 5-6Y area with 6Y FR71 got traded down to 111.3 (6.74%) while 10Y FR96 yield still hovered around 6.91-6.94% area. Market players are now waiting for tomorrow's BI rate decision, where market expects 25bps rate hike. At end of day, benchmark series of 5/10/15/20Y closed with yield movement of +2/+2/0/-1 bps.


