# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

### **FLAT**

JCI slightly strengthened and closed at 6,097 (+27 points or +0.44%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net outflow of IDR 3Bn today and rupiah slightly strengthened to IDR 14,423/USD.

Consumer stocks were positive as UNVR (+4.27%), KLBF (+3.57%), INDF (+1.65%), MYOR (+1.36%), and HMSP (+0.48%) all up. Banking names were mixed as BBRI (+0.81%), MEGA (+1.59%), and BBNI (+0.84%) closed higher, while BMRI (-0.44%) and BBCA (-0.17%) declined. Retailer stocks were mostly positive as AMRT (+5.56%), MAPI (+4.03%), and MAPA (+5.5%) all up, except ACES (-1.14%). Telco names were mixed as TLKM (+2.16%) and FREN (+4.67%) rose, while EXCL (-1.49%) weakened. Other movers were BABP (+23.46%), DSSA (+17.3%), MAYA (-6.92%), and BINA (-5.58%).

Iron and Steel export grew by 93% yoy in 6M21, and is now the second biggest non-oil and gas export from Indonesia

## **BOND MARKET**

#### **TIGHT RANGE**


The bond market managed to end slightly higher today. Prices moved in tight range throughout the day as overall market tone was biddish and crowded by both interbank as well as onshore players. Market witnessed tight trading range particularly in front to belly part of the curve. However, the positive price action was quickly capped by profit takers.

There will be fresh supply tomorrow as Indonesia Debt Management Office ("DMO") will hold conventional bond auction with IDR 33Tn issuance target. The series that will be issued are 3M SPN, 9M SPN, 6Y FR90, 11Y FR91, 15Y FR88, 21Y FR92 and 30Y FR89. In the previous conventional auction, incoming bids reached IDR 95.55Tn and DMO issued IDR 34Tn.


