INDONESIA MARKET WRAP

EQUITY MARKET

Sold Off

JCI weakened and closed at 6,639 (-155 points or -2.28%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 572Bn today and rupiah slightly weakened to IDR 14,968/USD.

Banking stocks were negative as MEGA (-4.39%), BBNI (-2.55%), BMRI (-2.63%), BBRI (-2.42%), and BBKA (-2.76%) all down. Consumer names were negative as HMSP (-2.56%), ICBP (-1.34%), UNVR (-2.69%), INDF (-2.85%), and KLBF (-2.97%) all corrected. Retailer stocks were negative as MAPA (-6.45%), LPPF (-6.25%), ACES (-6.45%), and AMRT (-4.48%) all closed lower. Telco names were negative as ISAT (-1.19%), EXCL (-6.25%), and TLKM (-0.75%) all weakened. Other movers were MPRO (+10.34%), HITS (+9.82%), ARTO (-6.74%), and BRMS (-4.24%).

The Finance Ministry is confident that the state budget deficit will drop below 4% of GDP this year, despite increased spending. The significant growth in state revenue can be attributed to increased commodity prices and recovery in tax collection.

BOND MARKET

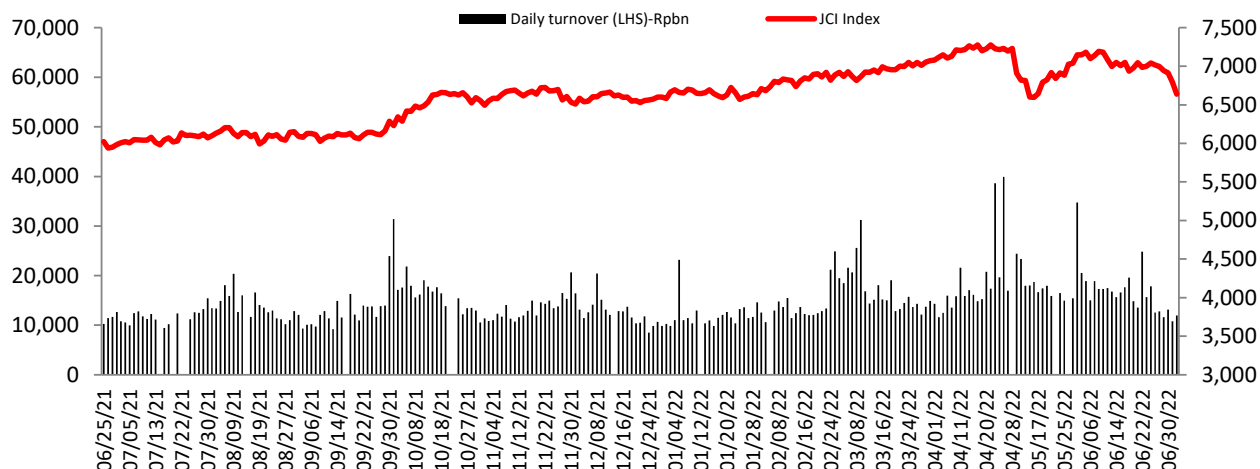
SLOW DAY

Bond market opened the week softer and bidders were on defensive mode. Overall market was relatively quiet with small trades on benchmark series. There is not much activity both from local and foreign as most players prepared for tomorrow auction. By the end of day yield curve ended flat. The 5Y/10Y/15Y/20Y benchmark closed the day at mid yield of 6.15%/7.27%/7.33%/7.25%.

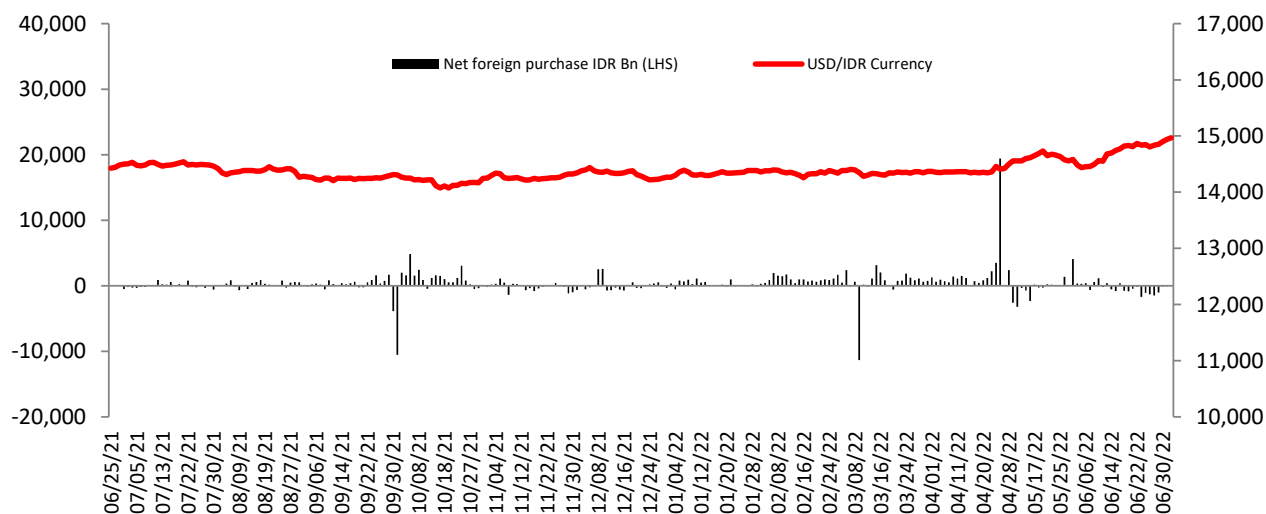
There will be fresh supply tomorrow as Indonesia Debt Management Office ("DMO") will hold conventional bond auction with IDR 15Tn issuance target (max upside IDR 22.5Tn). The series that will be issued are 3M SPN, 1Y SPN, 5Y FR90, 10Y FR91, 15Y FR93, 20Y FR92 and 30Y FR89. In the previous conventional auction, incoming bids reached IDR 35.064Tn and DMO issued IDR 18.88Tn.
