DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

LOWER

JCI weakened and closed at 6,534 (-74 points or -1.13%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 974Bn today and rupiah was stabilized at IDR 14,323/USD.

Banking stocks were negative as BBTN (-2.29%), BBNI (-2.16%), BMRI (-2.44%), BBRI (-1.92%), and BBCA (-1.69%) all closed lower. Consumer names were mostly negative as INDF (-3.08%), GGRM (-4.2%), ICBP (-4.79%), and UNVR (-3.24%) all retreated, except KAEF (+6.61%). Construction stocks were negative as ADHI (-4.65%), WSKT (-3.07%), PTPP (-6.22%), and WIKA (-5.69%) all corrected. Retailer names were negative as ERAA (-0.8%), MAPA (-5.32%), ACES (-4.4%), and AMRT (-2.07%) all weakened. Other movers were TMAS (+20%), TCPI (+8.92%), BRPT (-6.6%), and TLKM (-3.62%).

President Joko "Jokowi" Widodo has promised businesses that their investments will not be affected by the recent Constitutional Court ruling on the Job Creation Law, saying his administration would immediately work on a do-over of the lawmaking process.

SLIGHTLY HIGHER


Indonesia bond market opened unchanged today. In the morning session, we heard small buying activity in front to middle tenor. Until in the middle of the day, Moderna's CEO told that existing vaccines will be less effective at tackling omicron. Post the news, market took a u turn as several selling interest was came to the market. Mixed names selling in 5Y areas. Overall yield curve closed slightly higher by 3 – 5 bps. Total foreign ownership went down to IDR 925.24Tn on November 26th 2021, from previously IDR 949.27 on October 29th 2021.




