DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

WEAKENED

JCI weakened and closed at 6,288 (-55 points or -0.86%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.6Tn today and rupiah was stabilized at IDR 14,253/USD.

Banking stocks were mostly negative as BDMN (-1.81%), BBCA (-0.22%), BMRI (-0.77%), and BBRI (-1.01%) all declined, except MEGA (+5.63%). Consumer names were mostly positive as UNVR (+4.27%), ICBP (+2.02%), HMSP (+1.43%), and INDF (+1.17%) all closed higher, except KLBF (-0.72%). Poultry stocks were negative as MAIN (-3.18%), JPFA (-4.79%), and CPIN (-2.77%) all down. Material names were negative as TPIA (-1.75%) and BRPT (-4.62%) all closed lower. Other movers were DSSA (+15.98%), BUMI (+8.33%), POLL (-6.85%), and MASA (-6.67%).

OJK shows that the value of fintech lending financing as of August 2021 reached Rp26.1tn, or an increase of 70.36% YoY. Even when outstanding loans are increasing, fintech seems able to maintain loan quality with an NPL ratio of 1.77%. Total loan value ytd was Rp249.94tn, up 105.1% YoY.

BOND MARKET

AUCTION SUKUK

The bond market saw no improvement in risk sentiment today although we witnessed two ways trading in the market. Lacking fresh catalyst, bond prices continued to trade range bound and concentrated on 10Y areas. Yield wise, there is no significant movement and yield managed to close the day lower around 1 to 3bps compare to yesterday's closing level.


In today sukuk auction, MoF was received incoming bids totaling at IDR 46.065Tn, and MoF managed to issuance IDR 5Tn (initial target: IDR 5Tn). The series absorbed (against incoming bids) on the auction were IDR 0.4Tn (IDR 5.63Tn) 6mo SPNS, IDR 0.9Tn (IDR 10.299Tn) 3Y PBS31, IDR 1Tn (IDR 4.575Tn) 5Y PBS32, IDR 1.1Tn (IDR 11.476Tn) 13Y PBS29, IDR 1.1Tn (IDR 8.035Tn) 16Y PBS4 and IDR 0.5Tn (IDR 6.05Tn) 25Y PBS28 at cut off yields of 2.81%, 4.20%, 4.94%, 6.35%, 6.4%, and 6.98%.




