## INDONESIA MARKET WRAP

---

### EQUITY MARKET

#### ADJUSTED DOWN

JCI slightly weakened and closed at 7,898 (-33 points or -0.41%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.3Tn today and rupiah slightly weakened to IDR 16,160/USD.

Banking stocks were mixed as BBRI (+1.48%) and BNL (+0.32%) inched higher, while BBNI (-0.46%), BBTN (-5.19%), and BBKA (-0.85%) down. Consumer names were mostly negative as MYOR (-1.35%), INDF (-1.23%), UNVR (-4.37%), and KLBF (-3.48%) all weakened, except ICBP (+1.8%). Telco stocks were negative as EXCL (-1.35%), ISAT (-1.8%), and TLKM (-3.22%) all declined. Properties names were negative as LPKR (-3.26%), SMRA (-3.11%), PWON (-2.08%), and CTRA (-2.36%) all closed lower. Other movers were INPP (+24.05%), LIFE (+19.95%), INCO (-6.11%), and EMTK (-5.91%).

President Prabowo will deliver a state address regarding the government's performance over nearly 10 months. Meanwhile, the President will also present the introduction to the Draft State Budget for 2026 in his second speech.

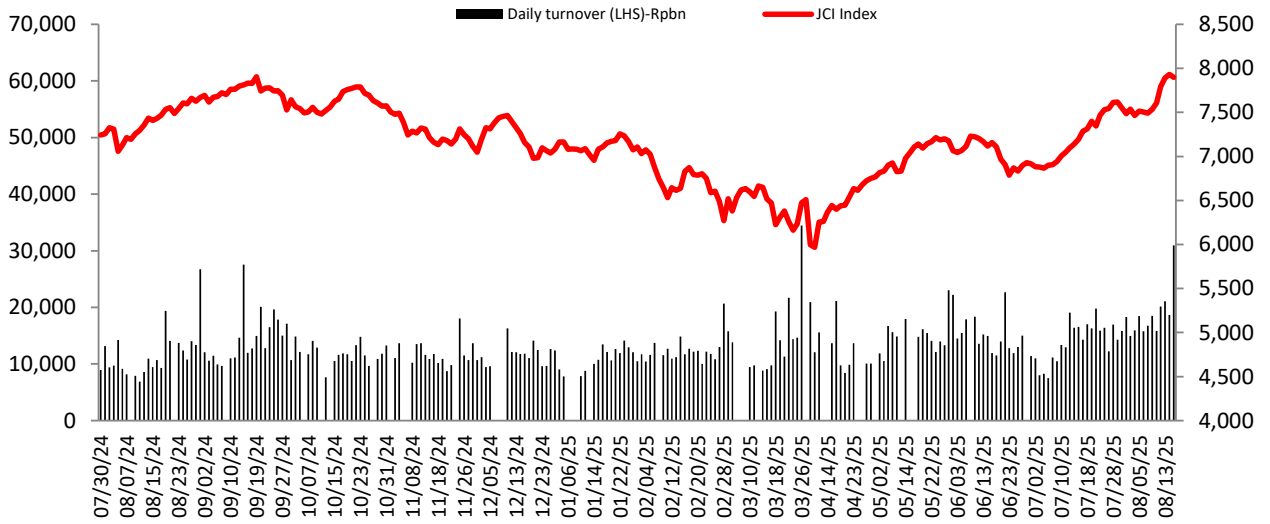
### BOND MARKET

#### Unchanged Sentiment

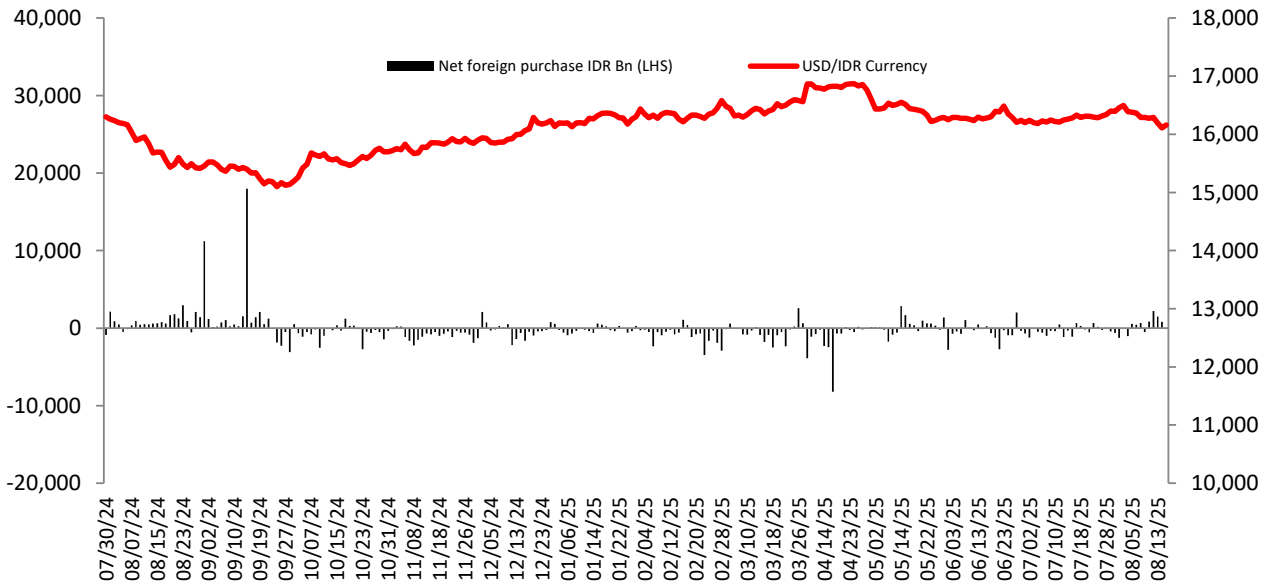
Indonesia bond market closed the week with unchanged sentiment. Market is still moving two ways in the morning session, although in the second session bond market was pretty quiet. Trading concentrated on front to middle maturities while the other part of the yield curve was quoted within range throughout the day. IDR bond the prices ended the day unchanged from yesterday level. The 5Y/10Y/15Y/20Y benchmark closed the week at mid yield of 5.86%/6.38%/6.77%/6.81%
