DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Mixed

JCI was flat and closed at 6,850 (-6 points or -0.08%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 747Bn today and rupiah was stabilized at IDR 16,295/USD.

Banking stocks were mostly negative as MEGA (-2.4%), BBNI (-1.12%), BBCA (-0.54%), and BMRI (-3.27%) all corrected, except BBRI (+0.23%). Cement names were negative as SMCB (-6.25%), SMBR (-6.54%), INTP (-4.13%), and SMGR (-6.96%) all down. Consumer stocks were mixed as INDF (+1.22%), KLBF (+0.64%), and ICBP (+0.24%) advanced, while GGRM (-2.26%) and HMSP (-2.82%) weakened. Pulp & paper names were negative as TKIM (-4.15%) and INKP (-5.57%) all corrected. Other movers were CLEO (+6.61%), MPRO (+4.44%), BFIN (-6.19%), and ISAT (-3.84%).

The Govt has issued a permit to import completely built up (CBU) electric cars for BYD. The amount of imports given to BYD is around 10-20% of total production capacity.

BOND MARKET


FLAT TRADING DAY

It was slow day for the bond market ahead of the two major event risks tonight, US CPI and FOMC + Dot Plot. Overall market was relatively quiet throughout the day with small trade done in middle series. Market players were defensive and stay sidelined throughout the day. The benchmark series of 5, 10, 15 and 20Y closed at mid-yield of 6.95%, 7.02%, 702% and 7.07% respectively. Spot opened at 16290/16300, and closed at 16290/16299.


