DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Lower

JCI slightly weakened and closed at 7,277 (-35 points or -0.48%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net outflow of IDR 370Bn today and rupiah slightly weakened to IDR 15,740/USD.

Banking stocks were negative as MEGA (-0.49%), BBTN (-2.08%), BBNI (-0.42%), BBCA (-0.76%), and BBRI (-1.22%) all corrected. Consumer names were mostly negative as HMSP (-1.16%), UNVR (-2.2%), ICBP (-1.51%), and INDF (-1.87%) all down, except KLBF (+0.67%). Pulp & paper stocks were negative as TKIM (-3.87%) and INKP (-2.79%) all weakened. Material names were positive as TPIA (+2.57%) and BRPT (+1%) all up. Other movers were PTBA (+4.26%), BRMS (+3.57%), BFIN (-2.91%), and EXCL (-2.73%).

The government is confident in setting an investment target of Rp 1,750tn next year, growing compared to the 2024 estimate of Rp 1,650. The Coordinating Ministry for Economic Affairs said the target had increased because the realization had also increased every year. It is recorded that in 2023, realization grew +17.5% to Rp 1,419tn.



Indonesia bond market start the week relatively flat despite 10Y UST yield lowered to 4.18%. In the morning session, we heard selling interest on front to middle end of the curve. Mixed interest was seen from foreign names while local names came as buyer. Overall yield closed 1 to 2 bps higher with local currency at 15,720/15,740 level. Tomorrow on Mar 5th MoF will hold regular Sukuk auction of 6M SPNS, 9M SPNS, 2Y PBS-032, 4Y PBS-030, 13Y PBS-004, 17Y PBS-039 and 25Y PBS-038 with indicative target of IDR 12Tn.


