DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

RETREATED

JCI weakened and closed at 6,716 (-41 points or -0.6%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net inflow of IDR 38Bn today and rupiah weakened to IDR 15,135/USD.

Banking stocks were mostly negative as BBNI (-0.27%), BBCA (-0.55%), BBRI (-0.92%), and BMRI (-2.83%) all corrected, except MEGA (+1%). Consumer names were mostly negative as HMSP (-0.53%), UNVR (-0.24%), ICBP (-1.1%), and INDF (-2.35%) all declined, except GGRM (+0.82%). Mining stocks were negative as INDY (-3.33%), PTBA (-1.42%), ITMG (-2.93%), ANTM (-2.23%), and ADRO (-2.86%) all closed lower. Retailer names were mixed as ACES (+9.92%) and ERAA (+4.17%) closed higher, while MAPI (-2.76%) and AMRT (-2.19%) corrected. Other movers were MPRO (+15.21%), SMGR (+2.8%), MEDC (-4.71%), and BUMI (-3.15%).

OJK recorded investment loan grew 12.69% YoY in May-23, supported by corporate sector which have begun to expand. Meanwhile, working capital loan grew 8% YoY and consumption loan grew 9.7% YoY in May-23. Overall, loan grew 9.4% YoY in May-23.


HIGHER YIELD

Indonesia bond market closed the week with higher yield around 3 – 10 bps followed by rupiah broke above 15,140 and UST touched at 4%. Selling pressure from onshore foreign banks remained thick in the air. Although we saw few bottom fishers came into the market, the buying failed to lend a support as prices went further south. In the meantime, market players are waiting for ahead of the major jobs data tonight. The 5Y FR95/10Y FR96/15Y FR98/20Y FR97 closed the week at mid yield of 5.96%/6.21%/6.40%/6.48%


