

# FOR PROFESSIONAL INVESTORS - 08/30/2021 DAILY REPORT INDONESIA MARKET WRAP

# **EQUITY MARKET**

### RECOVER

JCI advanced and closed at 6,145 (+104 points or +1.71%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 568Bn today and rupiah slightly strengthened to IDR 14,370/USD.

Banking stocks were positive as BBRI (+2.6%), BMRI (+2.59%), BBCA (+0.84%), BBNI (+1.89%), and PNBN (+1.97%) all advanced. Consumer names were positive as UNVR (+2.48%), ICBP (+3.61%), HMSP (+3.16%), KLBF (+2.2%), and GGRM (+2.11%) all up. Infra stocks were positive as TBIG (+4.79%), TOWR (+3.46%), PGAS (+1.98%), and JSMR (+1.59%) all inched higher. Mining names were positive as ADRO (+4.42%), ANTM (+2.21%), INCO (+2.32%), ITMG (+3.61%), and PTBA (+1.44%) all closed higher. Other movers were INKP (+9.56%), AGRO (+6.76%), PALM (-6.79%), and TURI (-6.69%).

OJK is preparing new regulations for fintech players so that the portion of financing services to outside Java is wider. One of them is that each platform must distribute at least 20% of its total annual funding distribution to outside Java.

## **BOND MARKET**

#### LOWER YIELD

Indonesia bond market start the week with biddish tone after last Friday's Jackson Hole event. As soon as market opened, high interest was seen led by 10Y areas. Mixed players was seen buying not only the benchmark series, but also non benchmark series. Significant price increase soon invited profit takers in market. Market closed with yields lower by 7 - 9 bps compared to last friday closing level with 5Y/10Y/15Y/20Y closed at mid yield 5.03%/6.09%/6.29%/6.88%.


There will be fresh supply tomorrow as Indonesia Debt Management Office ("DMO") will hold conventional bond auction with lower issuance target at IDR 21Tn. The series that will be issued are 3M SPN, 9M SPN, 6Y FR90, 11Y FR91, 15Y FR88, 21Y FR92 and 30Y FR89. In the previous conventional auction, incoming bids reached IDR 77.07Tn and DMO issued IDR 30Tn.




