DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

ADJUSTED DOWN

JCI weakened and closed at 6,102 (-36 points or -0.58%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 117Bn today and rupiah was stabilized at IDR 14,493/USD.

Banking stocks were mostly negative as BBNI (-1.46%), BMRI (-1.24%), BBRI (-0.77%), and BBCA (-1.95%) all retreated, except PNBN (+3.92%). Consumer names were negative as KLBF (-0.74%), MYOR (-2.18%), ICBP (-1.98%), HMSP (-1.74%), and UNVR (-4.48%) all down. Poultry stocks were negative as MAIN (-3.45%), JPFA (-2.32%), and CPIN (-3.49%) all down. Material names were negative as TPIA (-1.41%) and BRPT (-2.99%) all weakened. Other movers were MASA (+25%), BSIM (+24.86%), MAYA (-5.97%), and SMMA (-3.98%).

Bank Indonesia maintains the BI7DRR at 3.5%, deposit facility at 2.75% and lending facility at 4.25%.

BOND MARKET


FLAT

Indonesia bond market closed the week relatively flat today. We saw mixed trading although bond market general direction was offerish with several profit takers came to market. However, there was no significant price movement in the market with only limited trading was seen. Market was mostly dominated by local banks. The 5Y/10Y/15Y/20Y benchmark closed the week at mid-yield of 5.26%/6.3%/6.40%/7.08%. Yields were higher by around 1 – 4 bps across the curve.


