INDONESIA MARKET WRAP

EQUITY MARKET

Presistent Outflow

JCI advanced and closed at 7,156 (+120 points or +1.7%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net outflow of IDR - 401Bn today and rupiah slightly weakened to IDR 16,255/USD.

Banking stocks were mostly positive as BMRI (+2.59%), BBCA (+1.82%), BBNI (+1.46%), and MEGA (+1.43%) all closed higher, except BBRI (-1.24%). Consumer names were mostly positive as INDF (+2.07%), ICBP (+0.71%), SIDO (+2.84%), and HMSP (+1.2%) all inched higher, except MYOR (-2.07%). Material stocks were positive as TPIA (+2.39%) and BRPT (+9.14%) all inched higher. Infra names were positive as JSMR (+4.95%), PGAS (+3.13%), TOWR (+1.26%), and TBIG (+3.23%) all up. Other movers were HEAL (+17.89%), MAPI (+6.43%), BEKS (-7.89%), and BISI (-5.28%).

Finance Minister Sri Mulyani Indrawati predicts Indonesia's economic growth in the first quarter of 2024 will reach 5.17 percent, driven by strong household consumption.

BOND MARKET


LACKLUSTER TRADING

It was dull trading day for bond market with hardly any trade heard done at least from our end. Investors shied away ahead tomorrow auction. The 5Y/10Y/15Y/20Y benchmark closed at mid yield of 7.13%/7.22%/7.18%/7.14%. Looking ahead tomorrow, after 1-month auction hiatus, there will be fresh supply tomorrow as Indonesia Debt Management Office ("DMO") will hold conventional bond auction with IDR 23Tn issuance target. The series that will be issued are 3M SPN, 12M SPN, 5Y FR101, 10Y FR100, 15Y FR98, 20Y FR97 and 30Y FR102. In the previous conventional auction, incoming bids reached IDR 32.33Tn and DMO issued IDR 22.6Tn.


