DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

FLAT

JCI slightly weakened and closed at 6,097 (-9 points or -0.15%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 46Bn today and rupiah was stabilized at IDR 14,493/USD.

Banking stocks were mostly negative as BDMN (-1.38%), BBNI (-0.5%), PNBN (-2.53%), and BBRI (-0.78%) all down, except BMRI (+0.43%). Consumer names were mostly negative as HMSP (-0.9%), GGRM (-2.04%), ICBP (-2.58%), and UNVR (-4.26%) all corrected, except INDF (+1.15%). Infra stocks were negative as PGAS (-0.96%), TBIG (-1.59%), JSMR (-3.95%), and TOWR (-4.09%) all corrected. Mining names were negative as INDY (-1.85%), TINS (-1.2%), ADRO (-0.39%), INCO (-2.3%), and ANTM (-3.8%) all closed lower. Other movers were MTDL (+25%), BOLA (+24.85%), MAYA (-6.82%), and BTPS (-6.69%).

Wage subsidy will be given for employee who has income below Rp3.5bn/month and registered in the BPJS as of 30 June 2021. The subsidy will be at Rp500m/month which will be given for 2 months, with total budget of Rp8.8tn.

SUKUK AUCTION


Indonesia bond market traded slightly higher today on the back of buying interests from both locals and offshore players. Buying interest not only the benchmark series, but also non benchmark series. We saw few profit takers came into the market. By end of day yield across the curve went lower by an average of 3-4 bps.

In today sukuk auction, MoF was received solid incoming bids totaling at IDR 56.69Tn, out of which MoF upsized issuance to IDR 13.15Tn (initial target: IDR 12Tn). The series absorbed (against incoming bids) on the auction were IDR 1Tn (IDR 6.12Tn) 6mo SPN-S, IDR 5Tn (IDR 14.18Tn) 3Y PBS31 (new issuance), IDR 4.35Tn (IDR 13.27Tn) 5Y PBS32 (new issuance), IDR 2.65Tn (IDR 5.32Tn) 7Y PBS30, and IDR 0.15n (IDR 9.31Tn) 13Y PBS29 at cut off yields of 3%, 4.59%, 5.31%, 5.95%, and 6.51%. No winner on 25Y PBS28.


