DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Uptrend

JCI slightly strengthened and closed at 7,760 (+25 points or +0.32%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 287Bn today and rupiah slightly strengthened to IDR 15,465/USD.

Banking stocks were mixed as BBNI (+2.73%), BBCA (+0.23%), and PNBN (+8.4%) closed higher, while BBRI (-0.2%) and BMRI (-0.69%) down. Consumer names were mostly positive as INDF (+3.48%), ICBP (+2.4%), KLBF (+1.48%), and MYOR (+0.75%) all closed higher, except UNVR (-1.69%). Telco stocks were positive as TLKM (+1.97%), ISAT (+1.66%), and FREN (+3.7%) all rose. Hospital names were negative as SILO (-1.92%), HEAL (-4.52%), and MIKA (-5.5%) all declined. Other movers were MLPL (+34.43%), MLPT (+19.83%), BUMI (-4.79%), and ADRO (-3.08%).

Bank Indonesia (BI) reported an expansion in the manufacturing industry in 3Q24, according to its latest PMI report. BI PMI stood at 51.54 in 3Q24, softening from 51.97 in 2Q24, with respondents expecting further deceleration in expansion in 4Q24.

BOND MARKET


Nothing Change

Indonesia bond market closed the week relatively flat despite higher UST rates overnight after higher US retail sales data. The bond market saw no improvement in risk sentiment today although we witnessed two ways trading in the market. While we still witnessed mixed names showed their selling interest particularly after London opened although trading volume remained thin. Thin trading volume during the day pushed bidders to be more defensive. Yields were higher by around 2-3 bps across the curve.


