DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

ANOTHER CORRECTION

JCI weakened and closed at 6,259 (-32 points or -0.51%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR 957Bn today and rupiah slightly weakened to IDR 14,300/USD.

Banking stocks were mixed as BBCA (+1.19%), MEGA (+2.74%), and BBRI (+0.21%) advanced, while PNBN (-3.03%) and BMRI (-1.15%) closed lower. Consumer names were negative as GGRM (-0.81%), INDF (-1.21%), MYOR (-1.44%), ICBP (-1.16%), and HMSP (-1.37%) all weakened. Mining stocks were negative as INDY (-1.68%), ITMG (-1.89%), ADRO (-3.28%), ANTM (-3.97%), and INCO (-6.79%) all down. Pulp & paper names were negative as TKIM (-4.74%) and INKP (-4.35%) all down. Other movers were BOLT (+24.88%), MPPA (+22.22%), TBIG (-3.27%), and TOWR (-2.89%).

Indonesia's February net foreign reserves rose to \$138.79 billion from \$138.01 billion in January. The reserves increased for the 3rd consecutive months to a fresh record high, primarily underpinned by the government's foreign loan withdrawal and tax receipts.


OFFERISH

Indonesia bond market closed the week with lower yield around 10 – 17 bps on the back of Powell's dovish message and sent 10yr UST up to 1.57%. The overall market tone was offerish especially after London market opened. Bonds series was focused on the short to middle tenor. Yield curve closed higher with mid-yield 5Y/10Y/15Y/20Y at 5.78%/6.67%/6.40%/7.32%. Total foreign ownership went down to IDR 961.545Tn on March 03rd 2021, from previously IDR 971.404Tn on February 26th 2021. Spot closed at 14290/14310 level.


