DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

ANOTHER CORRECTION

JCI slightly weakened and closed at 6,955 (-9 points or -0.14%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 72Bn today and rupiah slightly weakened to IDR 14,342/USD.

Banking stocks were mostly negative as BDMN (-0.43%), BMRI (-0.31%), BBRI (-1.51%), and BBCA (-1.25%) all weakened, except BBNI (+0.91%). Consumer names were mixed as GGRM (+9.63%) and KLBF (+1.24%) up, while INDF (-1.63%), UNVR (-1.75%), and HMSP (-2.7%) declined. Properties stocks were negative as BSDE (-1.96%), SMRA (-3.14%), CTRA (-2.34%), and PWON (-2.97%) all declined. Telco names were positive as TLKM (+1.34%), ISAT (+1.92%), and EXCL (+0.38%) all closed higher. Other movers were BCAP (+9.68%), KPIG (+9%), ACES (-5.66%), and PTBA (-3.92%).

Gov't will allocate Rp7.3tn to subside the bulk cooking oil, using proceeds from the CPO fund (BPDPKS). The subsidy will be at Rp6,398/litre, thus it will be sufficient to cover 1.1m KL. The gov't has also increases the cap price of Rp14k/L for the bulk cooking oil, meanwhile there is no more cap for the packaged cooking oil.

BOND MARKET


UNEVENTFUL

There was nothing much happened in the bond market today. Morning session saw some selling activities in 8-10Y area but supported from bids from local players. The second session is more muted with several buying seen on short and long end bonds before going on sideways until closing time. At the end of the day, the benchmark series of 5Y/10Y/15Y/20Y closed at mid yield 5.55%/6.71%/6.67%/7.15%.


