# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

#### SLIGHT REBOUND

JCI advanced and closed at 6,608 (+47 points or +0.71%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR -1.2Tn today and rupiah slightly weakened to IDR 14,323/USD.

Banking stocks were mostly positive as BBCA (+1.72%), BMRI (+1.06%), BBRI (+0.24%), and BBNI (+1.09%) all rose, except MEGA (-1.18%). Consumer names were mixed as INDF (+2.36%) and KAEF (+6.64%) rose, while MYOR (-1.77%), HMSP (-0.99%), and UNVR (-1.7%) closed lower. Telco stocks were positive as TLKM (+3.24%), ISAT (+6.08%), and EXCL (+1.69%) all closed higher. Infra names were mostly positive as TBIG (+3.7%), TOWR (+2.15%), and JSMR (+1.97%) all in green, except PGAS (-1.28%). Other movers were BBYB (+17.97%), AGRO (+6.7%), MAPI (-6.33%), and SILO (-4.15%).

According to the Minister of Energy and Mineral Resources, Indonesia has 19 existing smelters, of which 13 are nickel smelters. It has planned to build another 17 smelters, with US\$8bn projected investment value.

## **BOND MARKET**

#### **MIXED TRADING**


Indonesia bond market start the week with wide spread specially in longer tenor. In the morning session , we heard several players came to market to collect front to middle tenors. Support was seen from the local players and onshore foreign banks. While on the afternoon session as we witnessed mixed names showed their selling interest particularly after London opened although trading volume remained thin. Thin trading volume during the day pushed bidders to be more defensive. The benchmark series of 5, 10, 15 and 20Y closed at mid-yield of 5.01%, 6.23%, 6.24% and 6.94% respectively.




