INDONESIA MARKET WRAP

EQUITY MARKET

HOLDING UP

JCI advanced and closed at 6,072 (+35 points or +0.58%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 501Bn today and rupiah slightly weakened to IDR 14,535/USD.

Banking stocks were mixed as BBRI (+3.57%), MEGA (+1.72%), and BBNI (+0.43%) inched higher, while BMRI (-0.79%) and BBKA (-1.84%) retreated. Consumer names were mixed as UNVR (+1.15%), HMSP (+1.48%), and GGRM (+2.28%) in green, while INDF (-1.48%) and ICBP (-1.12%) closed lower. Mining stocks were positive as ANTM (+4.66%), INCO (+2.99%), INDY (+4.44%), ADRO (+0.82%), and PTBA (+0.79%) all up. Material names were positive as BRPT (+4.08%) and TPIA (+1.37%) all up. Other movers were POLL (+8.95%), AMRT (+5.29%), TCPI (-5.94%), and EMTK (-3.23%).

The gov't has decided to mandate businesses to pay Eid holiday allowance (THR) in full this year. Last year, the THR was paid in stages and some companies still have not paid their 2020 THR.

BOND MARKET

SOFTER

Supportive sentiment post yesterday rally left no trace today as the bond market closed the day softer despite a promising opening level. The bond market trading activity was relatively quiet. Only limited trading was done in the secondary with market players mainly focusing in 10Y – 20Y area. No significant price reconciliation took place. Overall the yield curve lower by 1-2bps compared to yesterday's closing level.

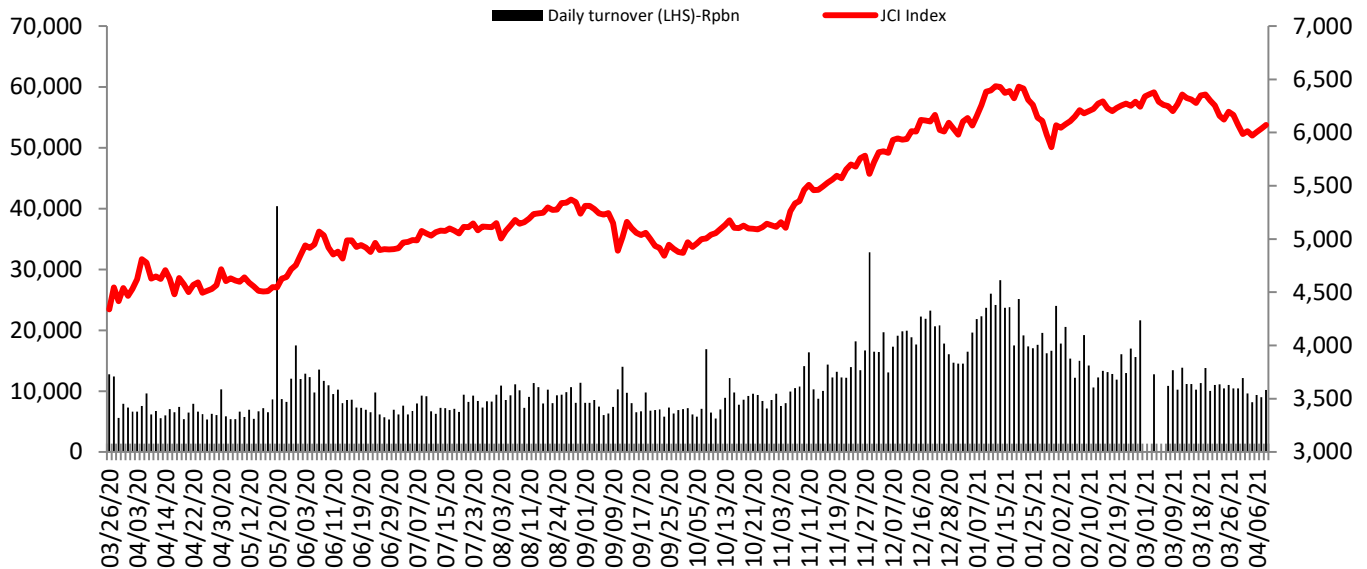

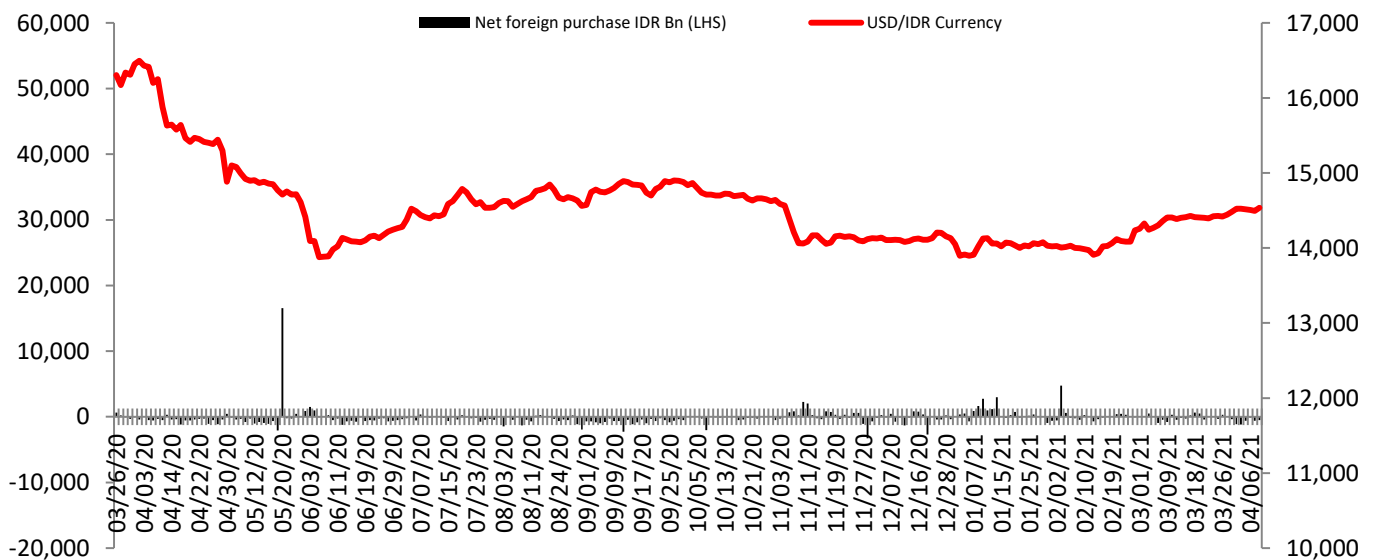
