INDONESIA MARKET WRAP

EQUITY MARKET

EDGED HIGHER

JCI was traded higher and closed at 4,594 (+26 points or +0.57%) today. Meanwhile, regional market performances were mixed with the crude oil surged above \$15 per barrel in New York after President Trump warned Iran on ships. Foreign investors recorded net outflow on 8th day of IDR 244Bn today and rupiah slightly strengthened to IDR 15,415/USD.

Consumer stocks were mostly positive as UNVR (+5.63%), MYOR (+7.73%), INDF (+3.57%), and ICBP (+1.25%) all rose, except HMSP (-0.95%). Banking names were following the similar path as BBRI (+0.36%), BDMN (+5.24%), BMRI (+0.22%), and BNLN (+1.23%) all inched higher, except BBCA (-0.49%). Poultry stocks advanced as CPIN (+4.87%), JPFA (+3.33%), and MAIN (+3.64%) all up. Telco names retreated as FREN (-6.48%), EXCL (-5.86%), and TLKM (-2.85%) all weakened. Other movers were MAPA (+20.32%), SCMA (+8.67%), SMSM (-6.81%), and CLAY (-6.78%).

Bank Indonesia (BI) optimistic Indo economy to rebound up to 6% of GDP in 2021 after 2.3% growth estimates this year.

It was a quiet trading for bond market today. Investors were comfortable stay sidelined lacking of any news to move the market. Bond prices continued to trade range bound and still focused on 10Y benchmark series. 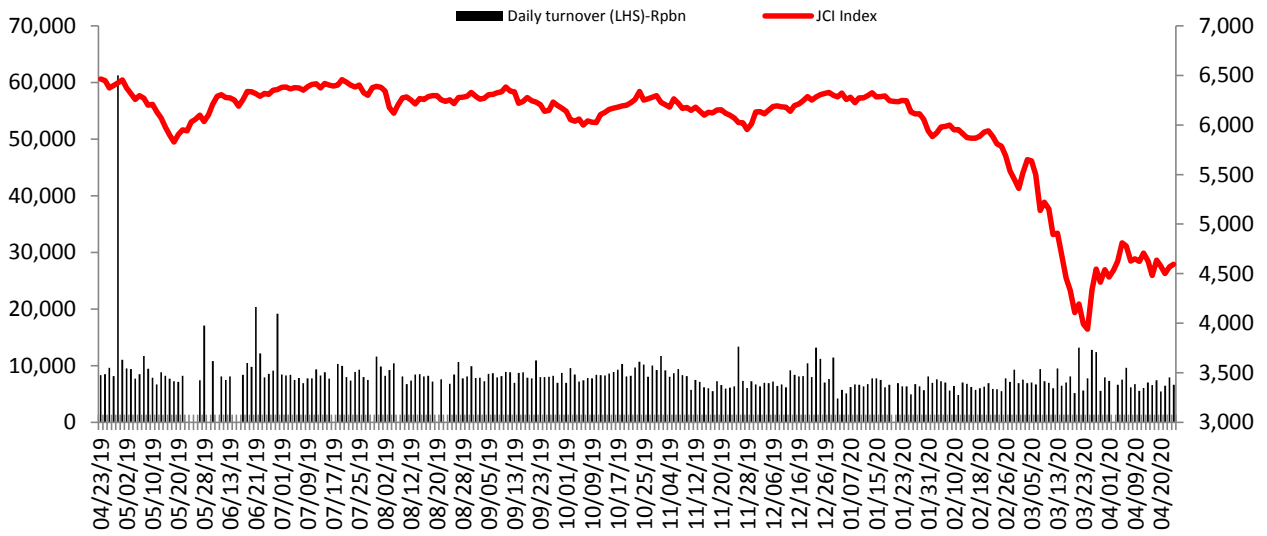

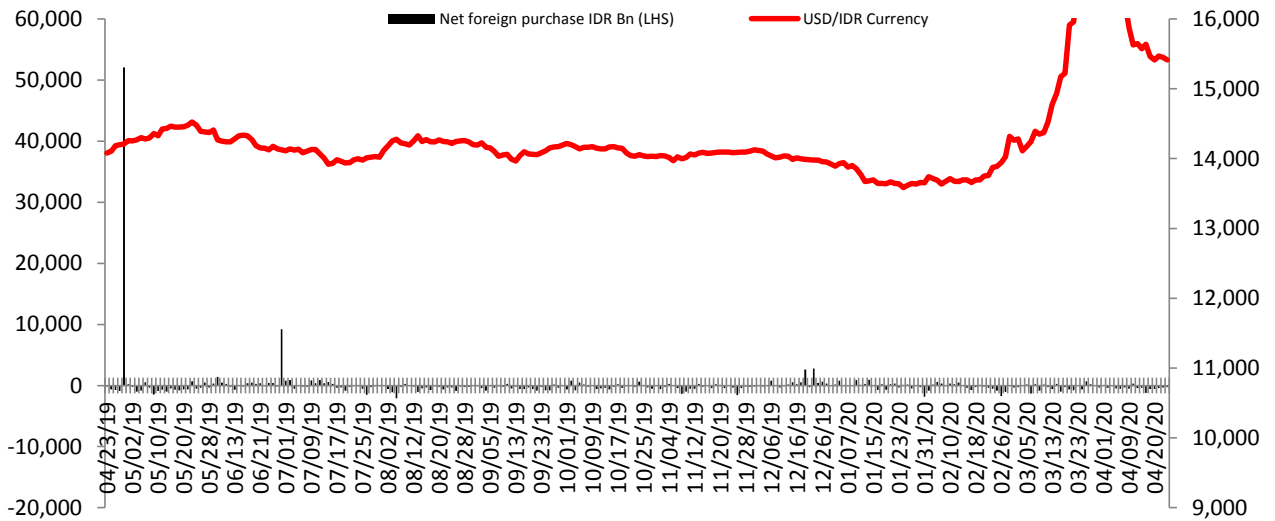
