# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

#### **REBOUNDED**

JCI advanced and closed at 6,920 (+58 points or +0.85%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 968Bn today and rupiah slightly strengthened to IDR 14,338/USD.

Banking stocks were positive as BBCA (+1.9%), BBRI (+1.13%), BBNI (+2.26%), MEGA (+0.78%), and PNBN (+1.23%) all inched higher. Consumer names were mixed as ICBP (+2.05%), KLBF (+1.85%), and UNVR (+0.26%) up, while SIDO (-0.52%) and HMSP (-1.02%) corrected. Pulp & paper stocks were positive as INKP (+5.1%) and TKIM (+4.26%) all closed higher. Mining names were mostly positive as ADRO (+4.04%), ITMG (+3.34%), PTBA (+2.38%), and ANTM (+0.92%) all rose, except INCO (-0.4%). Other movers were SUPR (+19.99%), BYAN (+2.78%), HERO (-6.76%), and KPIG (-6.25%).

State budget recorded surplus of Rp28.9tn as of January 2022, which is equivalent to 0.16% of GDP. The state revenue reached Rp156tn (+54.9% YoY, 8.5% of budget), while expenditure was at Rp127tn (-13% YoY, 4.7% of budget).

## **BOND MARKET**


#### QUIET

It was a quiet day for the bond market. Prices were quoted unchanged and spread widened. Although primary dealers continued to provide two ways quotation, at least from our end, not even moderate trading was heard. Yield curve ended with 5Y/10Y/15Y/20Y benchmark series stood at 5.32%/6.49%/6.48%/6.89%.


