DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

RECOVER

JCI slightly strengthened and closed at 6,864 (+34 points or +0.5%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 497Bn today and rupiah was stabilized at IDR 14,988/USD.

Banking stocks were mixed as BMRI (+3.27%), BBNI (+1.69%), PNBN (+0.41%), and BDMN (+0.64%) advanced, while BBCA unchanged. Consumer names were mostly negative as MYOR (-2.06%), UNVR (-1.17%), ICBP (-2.34%), and KLBF (-2.5%) all corrected, except GGRM (+1.88%). Properties stocks were positive as BSDE (+4.89%), CTRA (+3.69%), PWON (+2.89%), and SMRA (+2.19%) all up. Retailer names were mostly positive as AMRT (+1.82%), MAPI (+4.47%), and MAPA (+1.42%) all rose, except ACES (-7.33%). Other movers were BTPS (+5.94%), MDKA (+5.7%), ESSA (-2.86%), and CPIN (-2.35%)."

Ministry of Finance has officially released new regulation regarding export duties for the export of mineral concentrate products (PMK No.7/2023, replacing PMK No.39/2022). With the new regulation, the gov't will impose export duties for the export of mineral concentrate products for companies whose smelter construction has reached >50% in return for obtaining export permits relaxation


QUIET MARKET


