DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

EDGED HIGHER

JCI advanced and closed at 6,670 (+38 points or +0.57%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR -1.4Tn today and rupiah slightly strengthened to IDR 14,243/USD.

Banking stocks were mixed as BBCA (+1.32%), BBRI (+0.47%), and MEGA (+3.35%) advanced, while BBTN (-1.39%) and BMRI (-1.79%) weakened. Consumer names were mixed as INDF (+1.2%) and ICBP (+0.28%) rose, while GGRM (-0.61%), MYOR (-0.82%), and UNVR (-0.67%) retreated. Cement stocks were positive as INTP (+2.42%), SMGR (+0.78%), SMBR (+1.32%), and SMCB (+0.29%) all closed higher. Construction names were positive as WIKA (+1.56%), ADHI (+3.7%), PTPP (+1.65%), and WSKT (+0.55%) all in green. Other movers were TMAS (+24.62%), DSSA (+20%), BBKP (-6.79%), and POLL (-6.33%).

OJK assesses that the economy is starting to improve as reflected in the outstanding loan disbursement of IDR 5,652.8tn as of September 2021, an increase of 2.21% YoY. Credit is estimated to grow 6-7% YoY for 2022, higher than this year in the range of 3-4%.

LITTLE CHANGE


Indonesia bond market closed with little change today. The morning session opened with mini rally with local and onshore foreign banks as the main buyer. The appetite remained focus on front to 10Y area as well as long end series. 10Y FR87 got taken to 102.5 (6.14%) while 5Y FR86 got traded to as high as 101.83 (5.03%). In the second session, the gains were capped as profit takers emerged. At the end of the day, yield curve close mixed with 5Y/10Y/15Y/20Y benchmark closed the day at mid yield of 5.04%/6.14%/6.21%/6.86%




