# DAILY REPORT INDONESIA MARKET WRAP

# **EQUITY MARKET**

#### **ANOTHER CORRECTION**

JCI weakened and closed at 5,953 (-43 points or -0.72%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 106Bn today and rupiah was stabilized at IDR 14,450/USD.

Banking stocks were negative as BDMN (-2.69%), BBCA (-0.23%), BBNI (-2.19%), BBRI (-0.99%), and BMRI (-2.02%) all down. Consumer names were mostly negative as INDF (-0.77%), ICBP (-1.72%), HMSP (-1.14%), and UNVR (-1.67%) all declined, except MYOR (+4.07%). Material stocks were negative as TPIA (-1.74%) and BRPT (-3.5%) all closed lower. Telco names were negative as EXCL (-1.44%), ISAT (-4.56%), and TLKM (-0.94%) all closed lower. Other movers were AGRS (+24.85%), BMAS (+24.83%), MDKA (-4.96%), and TBIG (-3.23%).

## **BOND MARKET**

### **NOTHING CHANGE**


The bond market opened the day unchanged. IDR bond prices moved range bound throughout the day. Trading concentrated on front to mid maturities while the other part of the yield curve was quoted within range. In the middle of the day, Government announced CPI April recorded at 1.42% YoY/0.13% MoM lower against consensus (+1.5% YoY/ +0.17% MoM). Market players put on defensive stance. The benchmark series 5Y/10Y/15Y/20Y closed at mid-yield of 5.62%/6.45%/6.42%/7.18% respectively. Tomorrow on May 04th MoF will hold regular Sukuk auction of 6M SPNS, 2Y PBS-027, 4Y PBS-017, 13Y PBS-029, 16Y PBS-004 and 25Y PBS-028 with indicative target of IDR 10Tn.




