DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

FLAT

JCI was flat and closed at 5,938 (+5 points or +0.08%) today. Shares across regional markets were mixed with coronavirus developments weighing on the sentiment. Meanwhile, foreign investors recorded net outflow of IDR -1.3Tn today and rupiah slightly strengthened to IDR 14,080/USD.

Banking stocks were mixed as BBCA (+2.43%) and MEGA (+2.86%) inched higher, while BDMN (-2.35%), BMRI (-0.37%), and BBRI (-1.15%) closed lower. Consumer names were negative as ICBP (-1.26%), KAEF (-6.92%), UNVR (-0.99%), GGRM (-6.61%), and HMSP (-6.89%) all corrected. Telco stocks were positive as TLKM (+0.61%), ISAT (+4.3%), and EXCL (+1.65%) all up. Material names were positive as BRPT (+2.93%) and TPIA (+0.25%) all rose. Other movers were POLL (+24.73%), MASA (+24.71%), and ASII (-2.58%).

Vice SOE Ministry stated that 4 SOE banks will focus on each specialization for instance BRI will focus on the Micro sector, Mandiri on the wholesale and retail business, BTN on housing loan, and BNI will focus on the international business.


SUPPORT

The bond market closed the week on good buying sentiment. Foreign players were seen bidding quite aggressively hence pushed the yield curve lower by around 5-10bps. Trading activities were mainly done in 20Y area, especially FR83 followed by other series in the 5 - 10Y tenor. The 5Y/10Y/15Y/20Y benchmark closed at mid yield of 5.02%/6.10%/6.56%/6.69%.


