DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Correction

JCI weakened and closed at 6,957 (-60 points or -0.86%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 383Bn today and rupiah was stabilized at IDR 16,265/USD.

Banking stocks were negative as BBNI (-1.9%), MEGA (-8.88%), BBRI (-1.3%), BBCA (-1.55%), and BMRI (-2.26%) all corrected. Consumer names were mostly negative as SIDO (-2.48%), KLBF (-3.16%), ICBP (-3.15%), and INDF (-2.59%) all corrected, except UNVR (+1.45%). Material stocks were negative as BRPT (-3.96%) and TPIA (-3.23%) all retreated. Mining names were positive as INCO (+7.29%), ANTM (+2.7%), TINS (+4.67%), ADRO (+0.43%), and ITMG (+0.69%) all inched higher. Other movers were CMNP (+24.74%), JSPT (+19.78%), SMGR (-4.79%), and INKP (-4.1%).

Consumer Confidence Index (CCI) climbed from 125.9 to 127.7 in Dec-24 in the reporting period


1st Sukuk Auction

Indonesia bond market opened the day with widened bid ask spread following 10 UST yield touched 4.77%. Market players turned defensive and stay sidelined ahead of today sukuk auction. We heard no trade in the morning session, at least from our side. In the afternoon session, only limited activity on benchmark series were seen following local currency opened at 14,275. Its first sukuk auction of the year, government received incoming bids totaling at IDR 14.06Tn. MoF issued as per target, IDR 10Tn. The series absorbed (against incoming bids) on the auction were IDR 1Tn (IDR 1.095Tn) 6mo SPN-S, IDR 1.75Tn (IDR 2.565Tn) 12mo SPN-S, IDR 3.85Tn (IDR 4.86Tn) 2Y PBS3, IDR 0.6Tn (IDR 1.77Tn) 4Y PBS30, and IDR 2.8Tn (IDR 3.04Tn) 24Y PBS38 at cut off yields of 6.5%, 6.6%, 7.15%, 7.15%, and 7.33% respectively. No winner on 14Y PBS34 and 16Y PBS39.


